The Christchurch City Council opposes this amendment. It is considered that the values of Te Waihora Lake Ellesmere are such that the need to enhance and restore the waterbody justify the rule to maintain the exclusion of stock from artificial watercourses. Synlait Farms 1028 Heselton Road RD13 Rakaia 7783 Canterbury	11.5.29	The submitter is seeking to have the stormwater discharge rule amended to authorise clean small scale discharges to ground or onto land as a permitted activity. The Christchurch City Council opposes this amendment. This amendment is inconsistent with the rules in the proposed LWRP, and furthermore it reduces the incentive for developers to use SMPs. In addition "clean concrete areas" provide no certainty that the discharges onto them will be clean.	Oppose
