**Re: Environment Canterbury Draft Annual Plan 2014/15**

Thank you for your recent submission to our draft 2014/15 Annual Plan. We received 149 submissions this year, covering a wide range of activities. On 19 and 20 May 2014 the Council held public hearings in Timaru and Christchurch, at which 40 people presented their submissions in person. All written and presented submissions were considered by the Commissioners.

Consideration and decisions taken relating to the issues and requests provided in your submission follow:

**Issue AIR QUALITY**


When there is a huge earthquake, and when there is no supply of electricity, water or sewage, residents should have discretion to light an outdoor fire for cooking or for sterilisation of water. The Regional Council should not impose a total ban on lighting an outdoor fire at the very moment when outdoor cooking becomes necessary.

**Evaluation** There are provisions in the Canterbury Air Plan (including Christchurch) that provide for these types of emergency situations. Environment Canterbury continues to take a practical approach to these types of situations after such events.

**Decision** That the suggestion is noted with no change recommended to the draft Annual Plan 2014/15.
