E Can must have ^{be given} the power to deal and stop these types of people when needed.</p> <p>Keeping warm in winter via a woodburner does not give anybody the right to (poison) inflict woodsmoke on the neighbour's children in their own backyard.</p> <p>I believe peoples attitudes towards using ^{wood} burners needs to be changed and this starts with awareness of the harm of wood smoke but with education on burning the right fuel and good operation we can all have warm homes and</p>	<p>Implement Option 3: Encourage the installation of ultra-low emission wood burners region-wide, apply a "no visible smoke rule" inside and outside of polluted airsheds, continue to require Canterbury Region Council approved wood burners to be installed on sites less than 2 ha, and provide man for the burning of solid fuel in heritage buildings inside Clean Air Zones.</p>
