The number of working fireplaces listed for Riccarton House is **incorrect**. There has always been three open fires and one coal burner. It would appear that when writing the Air Plan the figures may have been entered incorrectly. The fires are not used as a primary source of heating, but are used for ambiance and effect only. They will be lit very infrequently during summer and occasionally through winter when the occasion merits. As part of our \$2.7m recent comprehensive restoration/upgrade programme, the Trust has gone to considerable expense to strengthen and restore the "working chimneys"
