Introduction

Thank you for the opportunity to provide input into the development of the Proposed Canterbury Air Regional Plan. Hurunui District Council wishes to acknowledge the extensive work undertaken by the Canterbury Regional Council to allow the Hurunui District Council to participate in the initial stages of the review and giving us the opportunity to submit feedback as part of the initial consultation process.

This submission is made by and reflects the views of the elected members of the Hurunui District Council. This submission represents a summary of Council's key views in relation to the proposed <u>rural discharges to air provisions.</u>

Hurunui District Council is in the process of reviewing the Hurunui District Plan. We consider it important that the Proposed Hurunui District Plan provisions are consistent with the provisions in the Proposed Canterbury Air Regional Plan. We seek to ensure that our District Plan provisions do not duplicate or conflict with the Proposed Canterbury Air Regional Plan.

Hurunui District Council supports the policy and rule framework for managing rural discharges to air and in particular the following provisions:

• Policy 6.26 The discharge of contaminants into air associated with rural activities do not cause offensive or objectionable effects beyond the boundary of the property of origin. (p.6-3)

Reason for submission:

We support the above policy as it ensures that there is a reduction in rural residents being affected by offensive or objectionable effects. The proposed policy is also likely to manage any reverse sensitivity effects.

Decision requested:

Retain Policy 6.26 without modification.

Rural discharges to air rules 7.60 – 7.69 (p.7-20 – 7-22)

Reason for submission:

The Proposed District Plan provisions have been adjusted to ensure that there are no conflicting provisions between the Proposed Canterbury Air Regional Plan and the Proposed District Plan. As a result, the Proposed District Plan does not contain any provisions which regulate to the discharge of contaminants into air from animal effluent or the establishment of new intensive farming activities within distances from sensitive activities. The Proposed Hurunui District Plan intends that the Proposed Canterbury Air Regional Plan would control these matters in the Hurunui district and the Proposed District Plan would only contain rules controlling the establishment of new dwellings or residential activities within close proximity to existing intensive farming activities or animal effluent disposal areas, so that the potential for reserve sensitivity effects are reduced.

Rural discharges to air rules 7.60 -7.65 (p. 7-20 - p. 7-21)

Intensive farming activities generate a variety of effects such as odour, noise and visual effects. Therefore it is crucial that these intensive farming activities are managed to ensure that rural amenity is protected while also allowing such farming practices to occur. We support the intensive farming rules 7.60 - 7.65 (p.7-20 - p. 7-21) and the associated setbacks which predominantly manage the effects and utilise separation as a way of mitigating effects.

Rural discharges to air rules 7.66 - 7.67 (p.7-21)

While the operative District Plan does not have any specific provisions regarding "stock holding areas" the Council recognises that farming practices are continually evolving to meet an array of needs and as a result, different options are appearing for shelter of stock, such as feed pads, herd houses, wintering and loafing barns. The intensive farming provisions have been adjusted accordingly in the proposed District Plan to recognise that such practices for sheltering of stock are included as intensive farming activities. The Council supports the 1500 metre setback from any land zoned for urban use but questions whether the 500 metre setback from the property boundary may be somewhat excessive and may limit the productive potential of the land. Given the main effect of stock holding areas, is on residential activities, as the quality of life and amenity levels of residents can be affected, it is considered that sensitive activities act as the trigger for the setback distance. To ensure that the productive potential of the land is protected, it is suggested that the setback distance be taken from where the stock holding area is situated on site to where an existing sensitivity activity is established, rather than from the property boundary.

Decision requested:

Give consideration to the 500 metre setback from the property boundary and the suggested course of action outlined, above which is for the stock holding area to be setback 500 metres from a lawfully established sensitive activity rather than from the property boundary.

Rural discharges to air rules 7.68 - 7.69 (p.7-21 - p. 7-22)

The Proposed Hurunui District Plan would control the establishment of new dwellings or residential activities within close proximity to existing animal effluent disposal areas. The Council supports rules 7.68 – 7.69 and the associated conditions that are required to be met.

Decision requested:

Retain rural discharges to air rules 7.60 – 7.69 without modification.

Conclusion

The Council supports the Proposed Canterbury Air Regional Plan and in particular, the rural discharges to air provisions. We consider that the policy and rule framework for managing rural discharges recognises that the rural environment is both a working resource for activities such as farming and a living environment for its residents and the provisions seek to balance these sometimes conflicting uses. The Proposed Canterbury Air Regional Plan provisions allow for rural activities to continue, supporting the economic, social and cultural wellbeing of the district,

subject to the appropriate management while also protecting the character and amenity values of the rural environment.
