6.39	Ultra-high efficient burners are still in development and frankly unaffordable. Recently saw one advertised for \$11,000.	Work with council and builders so that all new housing has at least a 6 star rating for efficiency
	Most gas and pellet fires rely on electricity. What happens when the electricity fails?	Stage the phasing out of low emission burners until ultra-high low emission burners.
	You risk snapping and set of wealth issues for another unless this is slowed down.
