The tables used for for meeting the nitrogen discharge requirements are inaccurate and hence don't allow for these rules to be lawful.

This affects low emitting farmers who should have permitted activity up to 15kg/ha at least.

We are a mixed cropping farm in the Waihao Wainono Catchment, fattening lambs and cattle as well. The farm has been in the family since 1945 and has a history of changing land use over that time to allow for changing markets and family circumstances. To take a brief history of 2009 -13 as our baseline is very restrictive of our farming activities and is not reflective of our past historical activities. We have operated at better than Good Management Practice over that base line period, but will now be very restricted in flexibility because we have been trying to do the right land management techniques for the environment. Our neighbours on the same soil types will be able to gain an advantage over us

in terms of N loss, land value, and inter-generational change because they have had more impact on the environment.

In 2012 we installed lateral irrigation on part of our property, using Waitaki water from MGII and are slowly developing the area under irrigation as sustainable economics allow. We are slowly changing the types of crops we grow to extract the best value for us and the economy. We are on class 1 soils (very good vegetable growing soils) and the base line definition, plus the poor flexibility caps severely impacts our business. Our two boys (10 & 12) will maybe take over our business and the only way forward for them will be to intensify to a degree that is sustainable economically and environmentally.

The base line definition is making liars of honest people and is doing nothing to improve the environment.
