Schedule 9 is out of date and does not reflect the loss of buildings resulting from the earthquakes. If it is not intended that dispensation should be given to all listed heritage buildings then the schedule should be created in close consultation with the heritage units of the relevant territorial authorities and Heritage New Zealand. Some buildings which occur on the list, eg churches, are highly unlikely to have non-complying space heating appliances so do not need to be listed. On the other hand it may well be desirable to allow a dispensation for some Category 2 buildings.
