Kia ora Sarah,

I do have some points I was trying to submit - however I was using a Mac and Safari browser, and didn't see anywhere to add my submission in the online portal, so gave up and just hit submit thinking I could edit later, but then wouldn't let me edit!

My points are (if not too late):

-Working Waters Trust supports the addition of known and **potential** inanga spawning sites to Schedule 17. These sites and modelling for potential sites should be revisited every 5 years or so due to sea level rise from climate change or after an earthquake with severe changes to riverbanks.

-Working Waters Trust proposes the addition of another schedule containing a list of Canterbury mudfish sites, with habitat protection policies and regulations, particularly preventing the destruction of any ephemeral habitat when dry.
