Genesis Energy Limited, trading as Genesis Energy ("Genesis Energy") welcomes the opportunity to provide a further submission on Proposed Plan Change 4 to the Canterbury Land and Water Regional Plan (LWRP).

In its original submission dated 22 September 2015 Genesis Energy sought that the LWRP positively implement the prescriptive and clear directions contained in the provisions of the National Policy Statement for Renewable Electricity Generation, and the Canterbury Regional Policy Statement, particularly in relation to enabling operation, maintenance and upgrade of hydro electricity generation infrastructure.

There is therefore no scope to provide the relief sought in terms of Schedule 24 and new policy 4.86C, as the submission points and relief sought are not related to a specific provision of Plan Change 4. 3. Even where scope exists (i.e. for all other submission points), with respect to the Tekapo White Water Course, and Tekapo and Pukaki Rivers, the relief sought is not the most appropriate way to achieve the objectives of the Canterbury Land and Water Regional Plan, recognising that: <ol style="list-style-type: none"> a.
