1. These are further submissions in support of or opposition to a number of submissions on the Environment Canterbury Regional Plan (the Plan) - Plan Change 4 of the Canterbury Land and Water Regional Plan.
2. PIANZ and EPFNZ could not gain an advantage in trade competition through these submissions.
3. PIANZ and EPFNZ made an original submission on the Plan.
4. PIANZ and EPFNZ have an interest in the Plan that is greater than the interests of the general public. They are the organisations that represent the interests of numerous poultry companies and commercial egg producers nationwide. Specifically to the Canterbury Region, PIANZ and EPFNZ represent:
  - 12 meat chicken breeders;
  - 44 meat chicken growers;
  - 21 layer farms;
  - 5 rearer farms;
  - 2 processing plants; and
  - 11 feed mills.
5. The further submissions are contained in Table 1 on the attached sheet.
6. We note the following in relation to the Summary of Decisions Requested Report provided by ECan:
  - A note was included in EPFNZ and PIANZ's summary of decision as follows.  
*[note. the submitter has based comments on an earlier version of PC4- issue may need clarification.]*

We have been in touch with ECan regarding this note and we have not yet received a reply. We are unsure of what the note relates to. Original submission was made on the latest and only known version of the Plan Change 4 text;

- Summary of submission point PC4 LWRP-248 states that the submitter (South Canterbury North Otago Branch NZ Deer Farmers Association) supports Plan Change 4 in its entirety. Upon further investigation into the submission, in no part does it state that the Plan Change 4 is supported in entirety; and
- Summary of submission point PC4 LWRP-280 states that the submitter (Te Runanga o Ngai Tahu) supports Plan Change 4 in its entirety. Upon further investigation into the submission, while the original submission states that the submitter supports Plan Change 4 in its entirety, there are points of opposition and requests for relief made.

7. PIANZ and EFPNZ wish to be heard in support of their submissions.

8. If others make a similar submission, PIANZ and EFPNZ will consider presenting a joint case with them at the hearing.
