- Our property has spray irrigation on some flat area and on rolling hills. Our water comes from the MGI company. We also farm some dryland rolling hill country bounding the platform that we use for drystock.

Reasons for my submission:

- My submission is in relation to the Waitaki Sub-Region 15B.4.10-15B.4.22 & 15B.4.26
- I would like to know why our property is going to have to get to 90% of GMP when it is in a "Green Zone" which from what I understand water quality is being met. I can understand that everyone should be farming at GMP but to have to be at 90% of GMP will have a major effect on the viability of our farming operation.
- I would also express my support for the Greater Waikakahi Zone Groups submission in which I fully support.

What I seek from my submission

- I would like to see as we are farming in an area that is meeting water quality we should have to be at GMP not 90% of GMP. This would still improve water quality I would suggest.
