- Our principle reasons for taking this position are set out in our narrative discussion, below, with specific outcomes detailed in the table.
- The Omarama Stream Water users group is a group of farmer owners whose properties
 are located in the Omarama Stream catchment who are working together to
 collaboratively discuss and address issues related to water quality in the Omarama
 Stream. The group has been actively working with Environment Canterbury for some
 time on this matter

Reasons for the Submission:

General

- The Plan in its current form is complex and difficult to understand and there are concerns that parts are unworkable and not enforceable. Our expectation as farmers of the plan, is that we should be able to pick it up and determine on our own, where our farming operation fits in.
- 2. We have concerns that some parts of the plan are unenforceable.
- Local stream and river water quality limits appear to be set in policy and tables with no supporting rule framework to enforce this. The next question is whether these levels set in Table 15B a) b) and c) are being set on actual water quality data and whether they are realistic and achievable.

Issues specific to the Ahuriri and Upper Waitaki Hill Zones

4. Table 15B(c) – water quality limits for Waitaki Rivers has limits for the Omarama Stream – spring fed upland for a number of different variables set at State Highway 8. We as a group require clarification as to how these limits have been set and would like input through the hearing process to ensure the levels being set are correct and achievable.

Relief Sought:

5. Seek confirmation that levels set in Omarama Stream are correct, set on actual data, are achievable and clarity on how they apply and are integrated into the rules.
