With the agreement of the committee, the Chair proposed that item 9 on the agenda be taken next.

#### 9 Hinds Plan and proposed region wide nutrient provisions

Recap on morning's Dairy NZ presentation and Variation 2:

- Some concern that there is in-equal treatment of BCI and RDR
- Clawback on intensification
- Lots of work done and the framework is still essentially intact to what the ZC recommended in the Hinds ZIPA.

#### 8 Forest and Bird

Edith Smith presented a selection of photos to the committee. Forest and Bird have an interest in braided rivers and the declining bird habitat in the river over time. Forest and Bird focuses include advocating for wildings control, Harris Reserve, native plant nursery, bird monitoring. The group has been encouraged to write a proposal to develop management plan for weed control in the Ashburton River.

John Henry reiterated that Arowhenua do not support spraying of river beds as this removes protection for native species. He believes that the best action is to increase water levels in the rivers for natural freshes to clear weed species in the river bed. Need to work together to solve the entire puzzle, not just one part.

#### 10 Updates

#### 10.1 Regional Committee

Commissioners have asked the Regional Committee for advice on an aspect of funding water infrastructure which has environmental or social or cultural benefits

#### 10.2 Hinds Drains Working Party

HDWP have met since Variation 2 and have also met with Arowhenua and had a field trip to the Managed Aquifer Recharge (MAR) site. Arowhenua is supportive of the MAR project. Also looked at a couple of proposed mahinga kai sites. Could be flagship sites for Canterbury.

Recommendations – report is being pulled together for the March Zone Committee meeting.

#### 10.3 Other

Freshwater discussion document has been put out by Government with a significant amount of funding put aside for environmental restoration <u>http://www.mfe.govt.nz/publications/fresh-water/next-steps-fresh-water-consultation-document</u>

ECan will be responding to this. A public meeting is to be held in Christchurch 17 March.

Trustpower have advised that they are awaiting one more contact and then will be able to proceed with inaugural trust meeting of the Rakaia Enhancement Fund.

Ecoli tracking study is underway and it is hoped that the results will be .available soon.

#### 10.5 Zone team recruitment

Recruitment for the Ashburton zone team is underway with some positions filled and some yet to be filled.

Dave Ashby has been working on part time basis and a number of things are reaching conclusions especially in the sensitive lakes zones.

Quite costly for each farm to get consents, FEP's etc.

Want to organise hui in conjunction with Arowhenua for farmers in that area.

Would like Zone Committee to organise industry liaison meeting to talk about overseer and other issues.

A workshop is proposed to be held prior to the April Zone Committee meeting.

Donna Lill met with ADC to discuss the stockwater strategy to meet river flow plan. Andrew Guthrie will attend the March meeting to discuss this.

## 7 Election of Deputy Chair

#### Purpose

## 9 Hinds Drains Working Party recommendations

#### Purpose

- 1 To provide an update on the work of the Hinds Drains Working Party (HDWP) since it last reported to the committee 24 November 2015.
- 2 To present the final recommendations of the HDWP.

#### Recommendation

That the Committee

- 1 Notes with appreciation the substantial work and contribution of the HDWP to the Canterbury Water Management Strategy in the lower Hinds catchment; and
- 2 Recognises the time and effort all HDWP members have invested to find common ground and agreement on this set of recommendations and in particular recognise the leadership of Peter Lowe as the Chair; and
- 3 Receives the final recommendations of the HDWP; and
- 4 Resolves to make a decision on adoption of the HDWP recommendations on 26 April after the committee has had time to read the final package of HDWP recommendations and supporting technical information.

#### Report

The HDWP was established in May 2014 by the Ashburton Zone Committee to work with the community and various stakeholders to develop a water body by water body management regime to deliver the Canterbury Water Management Strategy for the main water bodies of the Lower Plains.

The HDWP reported on progress to the zone committee 24 November 2015 and requested an extension to finalise their recommendations to allow an opportunity to respond to decisions on the Hinds Plains Plan Change (Plan Change 2) and to discuss the draft recommendations with the Arowhenua.

At the November meeting the HDWP provided the committee with a copy of their draft recommendations. This report provides a brief overview of work since November. A final copy of the HDWP recommendations will be tabled on 29 March 2016.

#### Progress made since last report

#### 21 February 2016 meeting with Arowhenua

The HDWP discussed draft recommendations with Arowhenua Mataitai Committee at Arowhenua marae. Later in the day the Mataitai Committee met members of the HDWP at the Managed Aquifer Recharge (MAR) site and the proposed mahinga kai sites.

#### Further work on minimum flow regime

Ongoing discussions within the HDWP has resulted in the development of a new generic adaptive minimum flow approach, and a trial of this approach for Boundary Drain.

In summary the approach is;

- Existing minimum flows until 2025
- Work toward a new adaptive minimum flow approach that;
  - enhances habitats and the opportunity for fish to migrate to and from the sea during high flows
  - provides for fluctuations in flow
  - o manages the ability to harvest water to storage during winter
  - provides for agriculture in the months when needed
- Drains south of the Hinds River
  - Apply existing minimum flows
  - Trial the new adaptive minimum flow approach on Boundary Drain
  - If successful, begin the process to review all minimum flows south of the Hinds River by 2023 and where appropriate introduce a new adaptive minimum flow approach.
- Drains north of the Hinds River
  - Step 1. Consistently meet existing minimum flows throughout the year
  - Step 2. Assess the effectiveness of the MAR trial
  - Step 3. Once existing minimum flows are met look to review and if proven and appropriate introduce a new adaptive minimum flow approach. Begin this process in 2023.

#### Adopting of the HDWP recommendations

Given the complexity of the package of recommendations and wealth of technical information that supports them it is proposed that the zone committee agrees to a three stage process for adopting the recommendations. This will give the zone committee time to read the recommendations, supporting information and ask questions of the HDWP.

The proposed adoption process is for the zone committee to:

- 1 Receive the final recommendations on 29 March, including a briefing from the HDWP and opportunity for the zone committee to ask questions.
- 2 Workshop before the zone committee meeting on 26 April and a question and answer session with the HDWP.
- 3 Adopt the final recommendations of the HDWP on 26 April 2016.

# 10 Zone Delivery Update: Summary of report findings for the Ashburton River/Hakatere to Rakaia River area

#### Purpose

To provide the Zone Committee with a summary of the key findings of a report completed by Dave Ashby for Environment Canterbury in 2015.

#### Background

The report focuses on the areas of the Ashburton District between the Ashburton River/Hakatere and the Rakaia River.

The report documents the work that has occurred in this area to assist with achieving the outcomes identified in the Zone Implementation Plan (ZIP).

This work includes that undertaken to assist landowners with complying with the various consent requirements of the Canterbury Land and Water Regional Plan.

The report also provides useful context and seeks to identify opportunities and priority areas for future work.

A presentation of the key findings of the report will be provided at the Zone Committee meeting.

## 11 Plan Change 2 update on appeals

#### Purpose

To inform the Zone Committee of appeals received in relation to Plan Change 2 and to consider the implications of this for the implementation of Plan Change 2.

#### Plan Change 2 Appeals

Plan Change 2 (Hinds/Hekeao Plains area) to the Canterbury Land & Water Regional Plan is the planning framework that manages the use of land and water resources in the Hinds/Hekeao Plains Area. Environment Canterbury appointed independent hearing commissioners to hear submissions and evidence, and make recommendations on Plan Change 2. On 4 February 2016, Council adopted the Hearing Commissioners' recommendations and the decision was publicly notified on 13 February 2016.

The Council's decision can be appealed to the High Court only on a point of law as per Environment Canterbury (Temporary Commissioners and Improved Water Management) Act 2010. Three appeals were received:

- 1. Barrhill Chertsey Irrigation Limited (BCI);
- 2. Combined Canterbury Provinces Federated Farmers (Federated Farmers);
- 3. Rangitata Diversion Race Management (RDR).

#### Implications for Plan Change 2 implementation

Plan Change 2 cannot be made operative until appeals are resolved. However, the "implementation phase" of Plan Change 2 can begin now with communication of the following simple messages to farmers:

- 1. All farming activities should aim to comply with industry-agreed Good Management Practices (GMP);
- 2. Farmers should initiate the preparation of Farm Environment Plans;
- 3. Farmers should also keep all OVERSEER input files and relevant farm input information.


More detailed implementation of Plan Change 2 is likely to occur after appeals are resolved and a decision is made by Council to make Plan Change 2 operative. At that point, Council is likely to develop additional material to aid understanding of the plan's requirements, hold public workshops, etc. Staff will speak in more detail about this at a future Zone Committee meeting.


