6 Confirmation of Minutes

1 Welcome and Karakia

The Chair welcomed everyone to the meeting and the opening karakia was offered by Peter Ramsden.

2 Apologies

Craig Fowles, Bill Thomas, Arapata Reuben (Te Ngai Tuahuriri Runanga), Gordon Guthrie advised he will be leaving at 2.30pm

3 Extraordinary Business

None

4 Register of Interests

It was noted that there is a need to clarify with Council how they wish to proceed in finding a replacement for Craig Fowles. Hope to have clarification on this by June meeting.

5 Confirmation of Minutes

That the minutes of the Ashburton Water Management Zone Committee meeting held on 29 March 2016, as amended, be taken as read and confirmed.

5.1 Matters Arising

Copy of Donna Field's farewell comments requested by Jackie Wright.

The DVDs from Bill Southward to be passed to Jackie Wright for viewing in the first instance, she will then pass around the group for viewing.

It was agreed that it would be appropriate to invite Richard Purdon (Ecan compliance) to the next zone committee meeting to discuss/confirm a monitoring and enforcement approach for the 2016-2017 year.

6 Correspondence

A resignation letter was received from Craig Fowles. It was noted that he had enjoyed his time on the Committee but due to work commitments he is unable to continue. A thank you letter to be sent from ECAN and also from the Committee. Craig hopes to attend the June meeting.

7 Hinds Drains Working Party Recommendations

John Waugh discussed a report he prepared on the groundwater levels in the Hinds area. He noted that the wells in Willowby and Lowcliffe areas are particularly low. The Glynchie and Westerfield graphs show that ground water levels have been high up until recently and are currently the lowest for 66 years. Chertsey wells water levels are also very low at present.

John Henry request information from records for groundwater bores from 1980s onwards to get an indication of how many wells have been drilled in this time period. In addition John and Jackie expressed interested in understanding the current consented volume of groundwater allocated versus the actual water used.

It was noted that irrigation consent conditions can vary, with some having specific timeframes for abstracting. Jackie Wright queried whether there a restriction on groundwater takes applies pending on groundwater levels (similar to a minimum flow restriction that would apply to surface water takes) It was suggested that there be an agenda item at next meeting which focuses specifically on groundwater including consent conditions and consented vs actual allocation.

Upper Hinds

A summary of statutory and non-statutory actions was provided for the Upper Hinds area.

<u>Statutory</u>: Plan Change 2 includes nitrogen and phosphorous limits which apply to the area. Water quantity provisions cap the existing allocation on the upper North and South branches of the Hinds River. There is also a requirement for landowners to comply with Farm Environment Plans (FEPs) and Schedule 24b.

John Henry raised his concern about the lack of rūnanga input into FEPs. He has found it very frustrating and advised that there is currently not enough funding to employ someone to be involved in this. John would like there to be processes put in place for this. He recommended that they should be involved in all the processes that are relevant. David Caygill believes that there may be a misunderstanding regarding how rūnanga are to be consulted with in Schedule 7 requirements. Clarification was sought on the current requirements for consultation and is to be provided at the next meeting.

<u>Non statutory projects</u>: Donna Lill provided an update to the Committee on the current IMS biodiversity projects. She advised that there are seven ongoing projects, all wetland and stream projects. There has been some extensive planting done and this is still ongoing.

A request was made to provide a summary of Plan Change 2 water quantity provisions at the next meeting.

8 Implementation Outcomes and Milestones

The Committee was asked for final feedback on the draft implementation outcomes and milestones as Donna Lill is now starting to draft a work plan for the zone delivery team. Jackie Wright raised a concern that the outcomes and milestones were drafted quickly and that there are some areas which are not covered. It was noted by the committee that there is a no milestone which specifically related to the urban environment/community. Olivia Smith encouraged the committee to consider a relevant milestone (s) for this. In doing so, John Waugh (community member) explained that there has been a significant increase in storm water from run off from paved areas in the urban environment. He also explained that water quality is reduced as it picks up debris etc. from surfaces. It was noted however that most new

subdivisions have an area to collect rainwater. It was confirmed that an additional milestone relating to Carters Creek and urban storm water be included. Jackie also suggested that rural drinking water should also be a milestone.

Donna Lill then explained that she will review the all the milestones (including the ones relating to urban environment and drinking water) and develop a work programme to deliver these. If any resourcing issues are identified, she will come back to committee to prioritise action.

It was also suggested that Donna Lill provides a quarterly report on progress with implementing the work programme. Donna explained that the committee could choose to have a 'champion' for each outcome. This would provide an opportunity for committee members to work with the zone team and champion the outcome including media conversations. It was agreed that the concept be discussed further at the next meeting.

9 Zone Delivery Update

Donna Lill advised the Committee that Sarah Heddell and Donna Field have recently joined ECAN. Two resource management officers have also been appointed and are starting in the next couple of weeks.

Sarah Heddell is currently working on implementing some of the Hinds Drains Working Party recommendations including the Mahinga Kai sites and Boundary drain trial.

10 Managed Aquifer Recharge (MAR) Pilot Project

Ben Curry explained how MAR Pilot Working Group is comprised of a range of members who are focused on getting the trial up and running. The site is was tested last week with water put into site and it responded as expected. The site has now been switched off as further work due to be done today/tomorrow to dig further holes.

Official opening is on Friday, 3 June at 1.30pm at Tinwald Golf Club. As there is lots of interest from community, especially the farming community, a public open day will be held on 15 June.

Olivia Smith explained that Bob Bower (Golders Associates) is interested in talking with the committee in Spring to discuss initial findings. It was suggested that this would be a good time for the committee to consider the establishment of a MAR Pilot Governance Group. David Caygill reiterated the importance of including the word pilot in the tile of the MAR Governance Group.

It was agreed that Ben Curry would be the representative from the Committee for the MAR pilot working group.

Gordon Guthrie left the meeting at 2.34pm.

The Committee adjourned for afternoon tea from 2.34pm until 2.51pm.

11 Rakaia Enhancement Fund

With the departure of Donna Field from the Committee, it was raised that a replacement representative is needed for the Rakaia Enhancement Fund Committee. Jackie Wright would be happy to attend but may have an issue with availability. It was agreed that the Committee will elect a representative at the next meeting and in the interim Jackie will try attend. If she is

unable to attend to, Chris Allen or Ben Curry will attend.

There is currently \$472,000 in the Trust at present.

It was noted that meetings will be monthly for the next 3 months with the next one taking place on 24 June from 11am – 1pm, venue tbc.

12 Recreational Water Quality Monitoring and Guidelines

Kimberley Dynes, Ecology Scientist provided a presentation on the monitoring process and guidelines for contact recreation.

Jackie Wright requested the addition of markers on graphs for E. Coli to be included to make the graphs so they can be interpreted more accurately. A question was also raised regarding why Rangitata and Rakaia rivers are not being tested as part of contact recreation programme. It was explained that there is limited funding to cover all rivers in the district and therefore popular for swimming spots are prioritised for monitoring.

It was agreed by the Committee to arrange a meeting at the testing site at SH1 on Ashburton River during the summer. A date is still to be agreed on for December/January.

13 Swimming Values in Canterbury and Recreational and Amenity Flagships

Ellie McNae guided the Committee through her paper on swimming values in Canterbury. Ellie advised that she will come back and talk to the Committee in August about potential flagship projects for the Ashburton zone. It was suggested that the committee consider ways to include the community in this.

Concern was raised around whether two consents were for extra water (Molloy/Townsend). It was thought that they are being swapped but clarification will be provided at the next meeting.

Olivia Smith suggested asked the committee if they may be interested in focusing on a different CWMS target(s) each month. The purpose of this is to link actions on the ground with each target whilst acknowledging the first and second order CWMS priorities.

Background


In April 2016 the committee considered a summary of the regional and Ashburton compliance statistics for the 2014/2015 year.

At the upcoming zone committee meeting Richard Purdon (Principle Resource Management Advisor, Environment Canterbury) will discuss a priority approach for compliance in Ashburton for 2016/2017. The approach is developed to reflect committee feedback provided at April zone committee meeting.

Ashburton Water Management Zone Compliance Monitoring Annual Report and Plan



Annual summary for 2014-15

Over-application and poor management of dairy effluent causing ponding were the main causes of non-compliance for dairy effluent resource consents (agricultural discharge category). These farms were a high priority for monitoring and any significant non-compliance had further site visits until resolved. With an increase in monitoring frequency combined with promotion of industry agreed Good Management Practices and leadership from industry, we hope to move these farms above the compliance bottom line next season.

Non-compliances relating to surface or ground water abstraction were either the result of water being taken on restriction, being taken over the allocated amount, having a faulty water measuring

device or for data not being submitted. These non-compliances will be a high priority for monitoring at the end of this irrigation season. Next season we will have a new data management system in place and we will be encouraging consent holders (through their industry providers) to provide real time data which will enable us to have immediate intervention following non-compliance. Real time data will alert farmers to system failures and help reduce the occurrence of technical non-compliance. Early intervention may reduce the occurrence of significant non-compliances due to water being taken over the allocated amount or being taken on restriction. We will also continue to work closely with our service providers.

Gravel extraction: Continue monitoring gravel extraction resource consents based on risk rating, focussing on significantly non-compliant operators. Remind all gravel operators of their bird survey obligations before the nesting season.

Stormwater: Meet consent holders' representatives on site before construction to go through resource consent conditions and management plans. Frequent visits will be made during construction with additional visits for any

Wastewater and industrial discharges: Continue monitoring based on the risk rating and ensure all sampling and reporting requirements are met in accordance with consent conditions.

Water abstraction: Ensure all water takes >10 l/s have meters in accordance with the national regulations. Prioritise and monitor consented water abstraction takes in accordance with region-wide procedures. All schemes and water user groups

Farming: Use our existing contacts with farmers to educate and promote GMP, establish baselines and maintain nitrogen loss calculations, and, for farms requiring a resource consent, develop Farm Environment Plans in preparation for obtaining a resource consent before 2017 and the FEP audit.

9 Plan Change 2 Update

Purpose

To provide the committee with an update on the status of Plan Change 2 rules.

Recommendation

The committee consider the update.

Background

Decisions on Plan Change 2 were publicly notified on 13 February 2016. Three appeals against Plan Change 2 have been lodged in the High Court by Rangitata Diversion Race Management Limited (RDR), Federated Farmers and Barrhill Chertsey Irrigation Limited (BCI). Federated Farmers have narrowed down the scope of their original appeal and therefore some of the rules in PC2 can be treated as operative.

All water quality rules including rules for irrigation schemes and incidental discharges and rules linked to the substitution of surface water with groundwater are still under challenge. Rules associated with stock exclusion, sediment removal, water transfers and augmenting groundwater or surface water can be treated as operative. The appended document provides the status of PC2 rules.

10 Rakaia Enhancement Fund

Purpose

For the committee to consider Zone Committee representation on the Rakaia Enhancement Fund.

Recommendation.

The committee **appoint** a Zone Committee representative on the Rakaia Enhancement Fund Committee.

Background

The Rakaia Water Conservation Order was amended in February 2014 to allow TrustPower to release water from Lake Coleridge for irrigation when the river is low, increasing the reliability of the water supply. Included in the conditions of the amendment was the establishment of the Rakaia Enhancement Fund.

The purpose of the fund is to fund projects within the Rakaia and Selwyn River catchments that are designed to enhance the cultural, ecological, and biological health and recreational opportunities within these catchments. The fund includes:

- Initial payment = \$50,000
- Annual payments = \$100,000 CPI adjusted (ends Dec 2031)
- Administration Funds = \$2,500 per annum

Rakaia Enhancement Fund Committee Membership

TrustPower has developed a deed to establish a committee to disperse the Rakaia Enhancement funds. Committee members include representatives from:

- Te Taumutu Runanga
- Te Ngai Tuahuriri Runanga
- Te Runanga Arowhenua
- Selwyn Waihora Zone Committee
- Ashburton Zone Committee
- Department of Conservation
- Environment Canterbury
- TrustPower Ltd

TrustPower envisages that the funds will be contestable and initially proposed that the committee would meet at least twice a year to assess applications in accordance with guidelines developed by the committee. To date, the committee has not met as frequently as intended and there have been no funds have been allocated.

13 CWMS Drinking Water Target

Purpose

To provide the committee with an update of work on the drinking water targets.

Recommendation

That the committee:

- Note the regional work currently underway on the drinking water targets
- **Discuss** drinking water issues and actions in the Ashburton Zone
- **Consider** future actions that could contribute toward achieving drinking water targets in the Ashburton zone

Background

The Canterbury Water Management Strategy (CWMS) includes 10 target areas. One of these areas is the drinking water targets. Access to safe drinking water is a fundamental requirement for public health, with the maintenance of community supplies a first order priority of the CWMS.

Within the strategy there are also targets that aim to increase the percentage of the population with access to drinking water that complies with the Drinking Water Standards, including a specific target for marae and papakāinga. The strategy also lists requirements to achieve nutrient efficiency targets and decrease nitrate concentrations in groundwater wells. Finally, there is a requirement to understand and manage emerging contaminant risks.

CWMS Drinking Water Targets

From 2015:

- For those communities that currently have access to untreated and safe drinking water, implement actions to ensure the source water quality remains high enough to meet the current Drinking Water Standards for New Zealand (DWSNZ) without treatment.
- Prevent further decline in source water quality for those communities that currently have to treat drinking water, such that this requires increased level of treatment or monitoring requirements.
- No new activities in a drinking water catchment that reduce access to sufficient quantities of drinking water supplies.

From 2020

• There is an increase in the percentage of the population supplied with water that meets the (DWSNZ) for health based determinants.

A key indicator to assess progress towards achieving the targets is the compliance of registered Canterbury community water supplies with DWSNZ. Environment Canterbury and the Canterbury District Health Board are currently examining the various metrics used to assess and report levels of progress around the drinking water targets. This work will ensure that the metrics used to assess are appropriate.

Regional update on drinking water targets

The 2015 CWMS Targets report noted that work on protecting source water quality amounted to 'progress', with over 140 recommendations made in Zone Implementation Programmes to set catchment load limits and to improve nutrient management specifically to protect drinking water. Environment Canterbury Zone Implementation Teams are now establishing programmes and targets to further advance this work.

It was also noted in the 2015 report that eight water supplies (three in communities under 500 people and three in communities of 500-5000 people) had lost compliance with the Drinking Water Standards (DWSNZ) since 2011/2012. Progress in the target areas of 'emerging contaminant risk' and 'catchment nutrient load' were both assessed as 'achieving'.

Environment Canterbury and the Canterbury District Health Board have a joint work programme with key work streams being drinking and recreational water targets. The joint work programme has resulted in more collaborative and proactive approach to identifying, mitigating and managing issues in this area.

Progress on drinking water targets in Ashburton Zone

A verbal update will be provided at the committee meeting. This update will consider both community and private drinking water supplies and specifically focus on:

- key drinking water issues in Ashburton Zone.
- actions underway to address and communicate issues.
- further actions that could be undertaken to progress drinking water targets.


