# Stakeholder engagement summary report

This document summarises the consultation that has taken place during the development of the Proposal for the Canterbury Regional Pest Management Plan ("the Proposal") as at 25 May 2017.

### **Consultation during development of Proposal**

In December 2015 Environment Canterbury released a discussion document on the future of pest management in Canterbury. The purpose of the discussion document was to seek the community's views on the best approaches to be taken in a new regional pest management plan.

Environment Canterbury received a total of 97 feedback responses and 13 public meetings were held. The intention across all of the public meetings was to provide an overview of the discussion document and review process, outline the proposed shift in focus, and seek detailed feedback from the community on current and future pest management.

The outcome of this consultation was general agreement on the concept of placing greater priority on prevention, early intervention and pest risk pathway management, but not at the expense of controlling existing legacy pests.

#### Ministers

Environment Canterbury met with representatives from the Department of Conservation (DOC) at various stages during the consultation process. In addition to general consultation around the process for the review and a high level structure of the Proposal, other discussion points were around establishing pests of mutual interest with DOC being the primary delivery agent, and management of specific interests such as Russell lupins, spartina, wallabies, rabbits and feral goats (under the Wild Animal Control Act).

General consultation also took place with Land Information New Zealand (LINZ) representatives as they are large landowners and will have 'Good Neighbour' responsibilities under the Proposal.

Environment Canterbury attended a workshop run by the Ministry for Primary Industries (MPI) to discuss requirements for the National Policy Direction.

#### Local authorities

Environment Canterbury has had meetings with neighbouring councils and consulted with them in relation to the process for the regional pest management plan review and high level structure of the proposal. Each meeting also had specific topics to discuss, in particular:

- Progress of Marlborough District Council and West Coast Regional Council's pest management plans to establish where they are at in their process and also to ensure that they align with the Canterbury Regional Pest Management Plan (CRPMP).
- Consultation with Otago Regional Council in relation to a joint work plan for wallaby management as an area of concern.

- Discussion with Timaru District Council, Ashburton District Council, Selwyn District Council, Kaikōura District Council, Christchurch City Council and Waimakariri District Council on managing pests on roadsides and gravel extraction conditions.
- Outlined with Ashburton District Council and Selwyn District Council the tension between protecting native vegetation on roadsides and impact from adjoining land occupiers having responsibility for pest management

Canterbury Planning Managers Group comprises representatives from each of the territorial authorities in Canterbury and Environment Canterbury including, Christchurch City Council, Waimakariri District Council, Ashburton District Council, Selwyn District Council, Hurunui District Council, Waimate District Council, Timaru District Council, Mackenzie District Council, Waitaki District Council, Ministry for the Environment and Te Rūnanga o Ngāi Tahu. There were several meetings with this group at various stages of the process. Apart for the general procedural information and consultation, there were some specific discussion topics which helped with the formation of the Proposal.

#### Tangata Whenua

Te Rūnanga o Ngāi Tahu representatives attended the Canterbury Planning Managers Group meetings as stated above. Environment Canterbury also consulted with Te Rūnanga o Ngāi Tahu representatives, the Rūnanga Working Group and Te Paiherenga to discuss the process for the regional pest management plan review and high level structure of the Proposal. Some specific talking points with these groups were around the link between biodiversity and production pest management, establishing other pests or organisms of interest, managing pests/organisms outside the plan, funding streams and the responsibilities and obligations of resource users.

#### Other persons

Environment Canterbury has held consultative meetings with key industry and interest groups such as NZ Merino, KiwiRail, Federated Farmers, NZ Forestry, Forest & Bird, Anti 1080 activists, Upper Rangitata Gorge Landcare Group, QEII Trust, Canterbury Pest Management Liaison Committees, District Councils mayors, Zone Committee chairs, Banks Peninsula Conservation Trust, Lyttelton Reserves Committee, the farming community and land managers. There is some overlap with landowner and community engagement.

#### Summary of feedback received through consultation

In general, feedback included:

- 1. General support for a more proactive approach to stop new pests becoming established in the region, including more surveillance and pathway management.
- 2. General opposition to reducing regulation of legacy pests, such as gorse and broom. Those that provided feedback were concerned that a reduction in regulation for these pests would cause an increase in their density and geographic spread, losing any gains that had been made in recent history.
- 3. Many new organisms (not currently included in the Regional Pest Management Strategy 2011-15) were suggested as pests for consideration under the proposed Plan that impact on biodiversity values.
- 4. There was clear support for the Proposal around:

- Keeping pests that are not in Canterbury out of Canterbury
- Regional benefits from reducing pest spread, e.g. keeping wallabies out of central and north Canterbury, and keeping Chilean Needle Grass out of central and south Canterbury.
- Good Neighbour Rules
- Retaining Community Pest Initiatives
- Rules to provide protection for pest control investments
- Greater level of regulatory support for wilding conifer control efforts
- Eradication of baccharies, entire marshwort, phragmites, egeria and rooks
- A focus on preventing wallabies establishing themselves in new areas
- 5. Key issues/concerns from general issues and concerns to more specific:
  - Maintaining current levels of control, not reducing efforts and losing gains made
  - The levels of coordination, management, and education associated with the new Plan
  - Keeping links between biodiversity and biosecurity visible in the Plan
  - A desire to know the specific rule requirements around boundary rule for gorse and broom
  - Managing pests on roadsides and the transport of pests through gravel extraction / use in relation to roading
  - The tension between protecting native vegetation on roadsides and impact from adjoining land occupiers having responsibility for pest management
  - The proposed declassification of ragwort, nodding thistle and variegated thistle received both support and opposition
  - Concern some land owners use the "excuse" of being required to eliminate the few isolated gorse/broom plants to clear native vegetation to increase production
- 6. Questions about what will be included in the Proposal and how aspects of the Proposal may work:
  - How to make the Plan work and what the rules need to look like along with the procedures and processes to implement compliance against the rules
  - The management of road reserves
  - The link between resource consent conditions and pest management
  - Whether the Regional Pest Management Plan would be solely land-focused or land and marine-focussed
  - Te flexibility to add or remove pests from the plan once it has been made operative
