



## 6. Deputations and petitions

## 7. Reports

7.1 West End Gap and Bikeshare Report (Refer pages 8 - 13 of the agenda)

Tim Cheesebrough presented the paper, which was taken as read. Discussion took place about extending the bike share area to the west to include Riccarton, Ilam and Birmingham Drive. It was recognised that a trial may be appropriate and funding provisions would need to be made in the 2018/2021 Long Term Plans.

The committee considered the staff recommendation in the report and agreed to clarify the timeframes for the shuttle bus and other possible trial options.

#### Resolved:

That the Greater Christchurch Public Transport Joint Committee:

- 1. RECEIVES the progress report on the West End Gap business case analysis and greater Christchurch based Bikeshare scheme;
- 2. AGREES that, while there is a likelihood of some form of long term central city shuttle bus service offering positive benefits for improved access to public transport services and central city regeneration, such a proposal should be re-visited when key central city developments are approaching completion and the central city travel network is more complete;
- 3. NOTES that the West End Gap analysis has identified a Bikeshare project is likely to offer some benefits to addressing the West End Gap problems and investment objectives by offering a means to improve accessibility both to public transport services and between key land uses and activities across the central city;
- 4. ENDORSES the early commencement of an Expressions of Interest process to the marketplace based upon the recommended initial option of a Christchurch Central City focussed Bikeshare scheme, with a progress report to the Committee at its August meeting:
- 5. ENDORSES staff to maintain close communications with NZTA and Auckland Transport over this initiative and to report back to the Committee further at the conclusion of the Expressions of Interest process and in the light of the parallel Auckland Transport business case analysis.
- 6. AGREES that the central city shuttle, including possible short term trial options, along with bike share scheme options be considered as part of the current public transport network review, and that appropriate funding provisions be made in the 2018-2021 Long Term Plans for Environment Canterbury and Christchurch City Council.
- 7. THAT staff report back on the trial option indicated in resolution 6 in September 2017.

# 7.2 <u>Metro Monitoring Report</u> (Refer pages 14 - 17 of the agenda)

Edward Wright spoke to the report. Patronage for May 2017 on the Purple and Orange lines experienced good growth, and some of the connector routes experienced an increase as well; however, the Orbiter and Blue line experienced minimal growth.

There was no statistical data available regarding whether the changes to services in the Waimakariri District had led to a change in congestion levels. Edward said he would check with the Christchurch Transport Operations Centre (CTOC) and report back next month.

### **Purpose**

 This paper proposes changes to the schedule of the Greater Christchurch Public Transport Joint Committee (Joint Committee) meetings and workshops for the remainder of 2017.

## Value proposition

2. The Joint Committee has a significant work programme, covering a wide range of substantive issues, including the preparation of the draft Regional Public Transport Plan. In order to provide the Joint Committee with sound advice in a timely manner about these issues, a revised schedule of meetings and associated workshops for the remainder of 2017 is proposed.

#### Recommendations

3. That the Greater Christchurch Public Transport Joint Committee:

Approves the revised schedule of meetings and workshops for the remainder of 2017.

#### **Discussion**

- 3. Currently the Joint Committee is scheduled to meet on the third Wednesday of each month. This involves a workshop where information is shared about topics which feed into the work programme of the Joint Committee, most particularly about the development of the Regional Public Transport Plan. No decisions are made in these workshops. A formal public meeting follows immediately afterwards.
- Given the significant work programme, and the present stage of the Regional Public Transport Plan review and development process, there is currently a great deal of content for the workshops. However, over the past few months there have not been a large number of reports for consideration in the formal meetings, and this situation appears unlikely to change for the remainder of 2017. Once the draft Regional Public Transport Plan has been developed, full public consultation on it will commence.

- 5. The Joint Committee Officers Steering Group has considered this issue, and recommend that, given the wide range of substantive issues for committee members to be briefed on over the coming months, an optimum use of the Joint Committee's time and resources would be to change the schedule of public meetings and associated workshops. The proposal is to hold the formal Joint Committee meetings every second month for the remainder of this year, with extended subject matter workshops in the alternate months.
- 6. This recommended cycle for the remainder of 2017 would enable the committee to receive briefings from local staff, national specialist advisors and others about a number of substantive and complex items associated with the Regional Public Transport Plan review.
- 7. The Steering Group is currently developing a communications plan for the Joint Committee. This will allow the work programme of the committee to be shared publicly once it has been prioritised.
- 8. The recommended revised schedule for meetings and workshops for the remainder of 2017 is:
  - 16 August: extended workshop
  - 20 September: workshop and formal public meeting
  - 18 October: extended workshop
  - 15 November: workshop and formal public meeting
  - 20 December: extended workshop

### **Purpose**

1. This paper provides members with an update on Greater Christchurch patronage for the year to date, as summarised in the attached monitoring dashboard.

## Value proposition

2. The monthly monitoring dashboard and report provides an overview of key performance indicators for the Greater Christchurch Metro network to enable effective monitoring of the services provided.

#### Recommendations

3. That the Greater Christchurch Public Transport Joint Committee: Receives this report for information.

## Key monitoring results

- 4. During June 2017 patronage totalled 1,147,095 trip boardings. This was down 0.76% compared to June 2016 figures.
- 5. The final patronage for the 2016/17 financial year was 13,467,568. This is 1.6% lower than the 2015/16 total of 13,682,047
- 6. While patronage in the 2016/17 financial year declined when compared to the previous year, the rate of this decline decreased as the year progressed. Patronage for the first half of the financial year (July December) was down 2.5% when compared to the corresponding period a year earlier, whereas for the second half of the financial year (January June) it was only 0.6% lower. Since January there have been three months with positive patronage growth, including the highest monthly patronage recorded since the February 2011 earthquake.

- 7. Public transport patronage in Greater Christchurch will continue to be closely aligned with the post-earthquake recovery, and particularly the return of businesses and employment to the central city. In 2016 central city employment numbers were assessed at 31,800, down from pre-earthquake totals in excess of 51,000 employees. It is estimated around 5,000 additional jobs will relocate to the central city in the period between November 2016 and November 2017, including staff moving into the new Justice Precinct which is due for completion shortly. This, together with the continuing growth in the hospitality sector in the central city, should result in ongoing opportunities for public transport to support these developments in the year ahead.
- 8. June patronage increased on two out of the five frequent lines in comparison to June 2016. In particular the Orange Line once again showed strong growth (4.9%). It is also of note that the Yellow Line and Orbiter are carrying significantly more passengers now compared to pre-earthquake levels: 15.5% and 7.1% respectively.
- 9. The Connector and school routes both reported increases in patronage for June with growth of 6% and 4.1% respectively. The result on the Connector routes may have been positively influenced by the recent increase in frequency on the 95 route in Waimakariri District, which has resulted in an increase in growth since the changes in April. This may also counter-balance the small decrease on the Blue Line service.
- 10. Patronage within both the Christchurch City Council and Selwyn District Council areas was lower compared to June 2016, with the Waimakariri District Council area experiencing slight growth.








