

Title

Appointment of Decision Maker to decide resource consent applications

Purpose

To appoint a Hearing Commissioner to consider and decide resource consent applications CRC172310 and CRC172311 to be held by Mackenzie District Council

Recommendations

That the Committee, in regard to resource applications CRC172310 and CRC172311 made by Mackenzie District Council

- (a) Appoints Sharon McGarry as a Hearings Commissioner under s34A of the Resource Management Act 1991; and
- (b) Delegates to Sharon McGarry pursuant to s34A(1) Resource Management Act 1991, the function, powers and duties required to: deal with any preliminary matters; consider, and decide the application.

Proposal

Background

Mackenzie District Council has applied for consents for use of land; and the discharge of treated wastewater into land which may result in the contaminant entering water and contaminants (odour) to air relating to the upgrade of the Twizel wastewater treatment plant at State Highway 8, Twizel.

The applications were jointly limited notified with Mackenzie District Council. One submission in support has been received. The submitter does not wish to be heard.

Mackenzie District Council received an application for a Notice of Requirement to alter the designation of the existing site and include additional land. They have requested the applications be decided jointly.

Discussion

The proposed commissioner, Sharon McGarry has satisfied Council staff she has the necessary criteria, including technical ability, RMA Accreditation certification, availability and timeframe commitments to carry out the duties required.

Legal compliance

S34A of the Resource Management Act 1991 allows Council to delegate functions to Hearing Commissioners appointed by the Canterbury Regional Council.

The Regulation Hearing Committee appoints Hearing Commissioners in relation to consent authority matters under the Resource Management Act 1991.
