The Chairperson welcomed Cr Nicole Reid, mid-Canterbury district councils representative to her first meeting.

4 Minutes of the previous meeting 8 August 2017

7 Zone Committee (ZC) Updates

Refer pages 12 to 14 of the agenda and tabled reports from Ashburton and Kaikōura

Waimakariri Zone Committee

Refer page 13 of the agenda

Carolyne Latham presented the update from the Waimakariri Zone Committee. In response to a question about the progress on the sub-regional plan she advised that they were waiting on scientific information on water moving under the river to use for modelling. This information will be shared with the Christchurch West Melton zone committee.

Ashburton Zone Committee

Refer page 2 of the tabled report.

Ben Curry presented this update and noted that there was some misunderstanding I the community about minimums flows in terms of the consents still being exercised and increased flows.

A request was made for information at the next meeting on new minimum flows and life of consents region-wide.

Ross Millichamp advised that the infrastructure working group had raised the potential for having a collaborative solution with hydro generators on using generation water for management of flows. Ben Curry offered to raise this with the zone committee.

Kaikōura Zone Committee

Refer page 1 of the tabled report.

Ted Howard presented this update and explained that the effects of the earthquake dominate water and life in Kaikōura. There is stress on farmers and many in the community. The zone committee is working on mitigation and resilience, and continuing biodiversity work in the Clarence.

Orari-Temuka-Opihi-Pareora

No report was provided. It was noted that more information is being obtained for the zone committee for the sub-regional plan. A report on this will provided to the next Regional Committee meeting.

8 Managed Aquifer Recharge

Refer pages 15 to 17 of the agenda

Brett Painter presented this report supported with a PowerPoint presentation with diagrams and maps.

Denise Tully described the public health outreach programme to raise awareness of the bacteriological quality of their water. A lot of people source water from their own bores and they wanted to encourage regular water sampling, and establish a base line for bores. Letters were sent to 500 households during the dry period November to December 2015. Denise observed that it would be interesting to re-do this again following wet weather. The recharge project will pick up more testing.

Brett explained that the Tinwald water quality issue was complex. There is a need to look at bore heads and casings. There is concern regarding septic tanks and Environment Canterbury is investigating sources of EColi.

In response to questions about the project, Brett said the recharge project addresses a piece of the puzzle and is adaptive management. There are decades of nutrients already in the system and work needs to continue. Analysis of the benefits will be addressed by the business case.

9 Update on CWMS Targets Reporting - 2017

Refer pages 18 to 19 of the agenda

Lesley Woudberg introduced this item and explained that it was opportunity to consider if the targets are fair and accurate for the CWMS.

Winton Dalley confirmed that the Canterbury Mayoral Forum had discussed the targets report and had endorsed the CWMS as the way to manage water in the region. The Forum supported settling new mid-targets during the 2020 to 2040 period.

Dann Olykan thanked the committee and the working group for the feedback provided following the last look at the targets. There were three more targets to be considered:

- Environmental Limits
- Drinking water
- Recreation and amenity

Lance Kenyon arrived at 3.00 pm

The following feedback was provided on two of the targets in the Targets Progress report 2017:

Page 30 - drinking water quality; what else can we be doing?

- Stock exclusion and reducing inputs has already started so are we addressing the target itself?
- Need to identify and provide more information about the communities are we talking about.
- How can funding be generated targeted rates? Users?

- Care when issuing consents for example a water supply well within a central pivot.
- Less cows.
- Better use of technology.
- Pasture management

Page 38 – Recreation Water Quality

- Consider recreational releases at times when people at most likely to be swimming – daylight during summer and holidays.
- Provide information on where the water quality is better.

10 Update on Farming at Good Management Practice Campaigns

Tami Woods presented this update and spoke to a PowerPoint "Farming at Good Management Practice".

Information was sent to farms likely to require consent under the operative Land and Water Regional Plan and subsequent Plan Changes. The following areas were not targeted this time:

- Kaikōura as people are under stress following the earthquakes
- South Coastal Canterbury still subject to Plan Change 3 appeals.
- Upper Waitaki Plan Change 5 hearings.

Tami explained the follow up work to be done, including compliance action if necessary.
