### Retain a Bus & School Bus Service (145) for Westmorland Residents

Ref: Page 14, section 4. of the Consultation Document - Long-Term Plan 2018-28

- 1 Signed Petition from local residents opposed to ECan axeing the 145:Westmorland bus / school bus service to be presented/talk to council during the consultation period.
- 2 School bus service needs to be an appropriate bus service that provides safe transport to our locally zoned public schools (Thorrington Primary, Chch South Intermediate and Cashmere High

- School). Note: ECan axed the school bus service (79) Dec 2014 and incorporated to the 145 without consultation with local residents. Having access to a school bus service means for our students that they don't need to battle the hill & busy roads to and from school, which is some distance away.
- 3 Destination of the service (Eastgate) is not considered appropriate for residents as locals need a service that will have access to the central city (access future developments such as the aquatic centre and stadium) so does need to be reviewed.
- 4 Route around Westmorland needs to take into consideration road changes (loop round Penruddock Rise & Ravensdale Rise) for more residents to access with development and further development of the subdivision.
- 5 If no access to public bus service, should residents pay for such a service (Rates)?
- What is the savings of using a smaller bus? 'MY Bus' service (appears that a small bus is being used at school time which is overflowing and large bus during off-peak times)?
- 7 Cost savings could be considered with reduction in frequency at off-peak times.

Westmorland rate payers require a bus service during peak times to connect its residents to central Chrischurch and children to locally zoned schools (e.g. Thorrington, South Intermediate & Cashmere High) Note: Westmorland lost the Cashmere School Bus Service (791) which was withdrawn Dec 2014 (replaced with current 145 service) Note: Acknowledge that the current bus route to Eastgate is not what residents would use (except our children to school).
