Identified Priorities for 2020

- The ecosystem health and mauri of Wainono lagoon and its catchments is improved - **Ongoing**
- All land is managed at good management practice and priority issues/areas are dealt with - **Ongoing**

- The biodiversity in the priority areas of Waitaki Mouth, Waitaki riparian wetlands, Northern Fan spring heads, and areas of grey scrub are protected and enhanced (**Committee asked for a report at April or May meeting**)
- There is widespread community understanding of and compliance with the Waitaki sub-regional section of the Canterbury Land and Water Regional Plan and Waitaki Catchment Water Allocation Plan - **Ongoing**
- We have increased catchment knowledge in priority areas (science) and we understand the effectiveness of interventions (monitoring) – **Ongoing**
- There is widespread ownership of catchment health by the community – **Ongoing**

- Presentation on Drinking Water Standards from the Waimate District Council staff
- Continued focus on the Wainono Lagoon and targets
- Information report at the March meeting on the current operational management of the Wainono Box (including lake levels, affect/issues with manual opening, protocols, obligation on drainage to landowners).
- Update on Braided River Margins Works (Lower Waitaki)

Black Hole Water Quality

Thank you for your email of 17 January 2018 regarding the water quality of the Waihao River and the amenity of the Black Hole swimming site.

The Lower Waitaki South Coastal Canterbury Zone Committee discussed your letter at our meeting on 14 February 2018. The Committee is aware of Environment Canterbury's (ECan) response to your Letter to the Editor of the Timaru Herald and ECan's further provision of information to the Timaru Herald (for their article in the Timaru Herald 16 February 2018). The Committee feels ECan has provided a balanced assessment of the factors affecting water quality in the Waihao River and a good summary of the work being undertaken to improve water quality and the amenity of the Black Hole.

The Zone Committee will continue to support remedial work around the Black Hole and in the catchment including working closely with the Waihao Wainono Catchment Group who will be taking a lead role. A new sign will soon be erected at the Black Hole to better inform the public of the status of the river, the improvement projects and alternative safe swimming sites.

Thank you for raising your concerns with the Zone Committee. The committee is involved in many initiatives to improve water quality in the zone and welcomes feedback from the community.

Subject **Clean Check Dry Advocacy Programme Report**

Purpose

To present the findings from the Clean, Check, Dry (CCD) Advocacy Programme and seek feedback to guide development of future CCD programmes.

Background

Bryce Warner, Fresh Water Advocacy Officer, carried out the CCD advocacy programme in the Waitaki Lakes District over the holiday period from 20 December 2017 to 6 January 2018.

Bryce's report (tabled in the February Lower Waitaki South Coastal Canterbury Zone Committee Agenda) covered what was accomplished, discovered, and highlighted as improvements by the CCD advocacy. While most of the report focusses on the Upper Waitaki Zone, Bryce did visit Lakes Aviemore and Waitaki and there are aspects of the report relevant to the Lower Waitaki Zone.

Gemma Livingstone (Bryce's supervisor) will discuss the findings of the report with the Zone Committee and give an overview of aquatic pest control.

Action Required

The Zone Committee receives the presentation and provides feedback.

Lower Waitaki Zone Committee River and Reach Options

Discussion 14 March 2018

Background:

The river bed - regional project to address regional issues

The Resource Management Act (RMA) defines the legal bed of a river for regulatory purposes. The river bed defines responsibility between regional and district council functions (including vegetation clearance, planting and earthworks).

The RMA definition is difficult to apply to braided rivers. The legal definition is often different to what is commonly referred to as riverbed. More certainty on the extent of the riverbed will provide guidance and help ensure activities are undertaken lawfully.

Environment Canterbury has previously used the 1:50 year flood lines as a guide and part of discussion for defining the river bed on a case by case basis. Environment Canterbury is now undertaking a more robust public process to get certainty about the extent of the riverbed.

The project:

Environment Canterbury is working with 4 zone committees and their communities across the region. The zone committees are Hurunui Waiau, Ashburton, Upper Waitaki and Lower Waitaki South Coastal Canterbury. We intend to identify the values on a reach (4-8km) of each river, how the river is managed for those values and consider the extent of the river bed as part of this management.

As agreed by ECan councillors:

The river reaches required to complete the project will be chosen in conjunction with the zone committees using the following criteria:

- a. Reach is braided;
- b. Complements reaches chosen on the other rivers regarding any river management (for example all reaches chosen should not be constrained within stopbanks).
- c. Reach does not include areas that are subject to consent applications or enforcement / compliance / legal processes involving Environment Canterbury or other agencies; and
- d. Reach has a range of values, with some including Ngāi Tahu values (not limited to mahinga kai).

Next Steps:

1. Identify the reaches

The table below contains information related to the criteria on the rivers / reaches in your zone to help your zone committee consider appropriate reaches. Once preferred reaches are identified, Environment Canterbury will collate all the existing information on the reach, using currently held information (e.g., flood lines, any existing LiDAR work, any territorial authority applications / processes and ECan or others' reports).

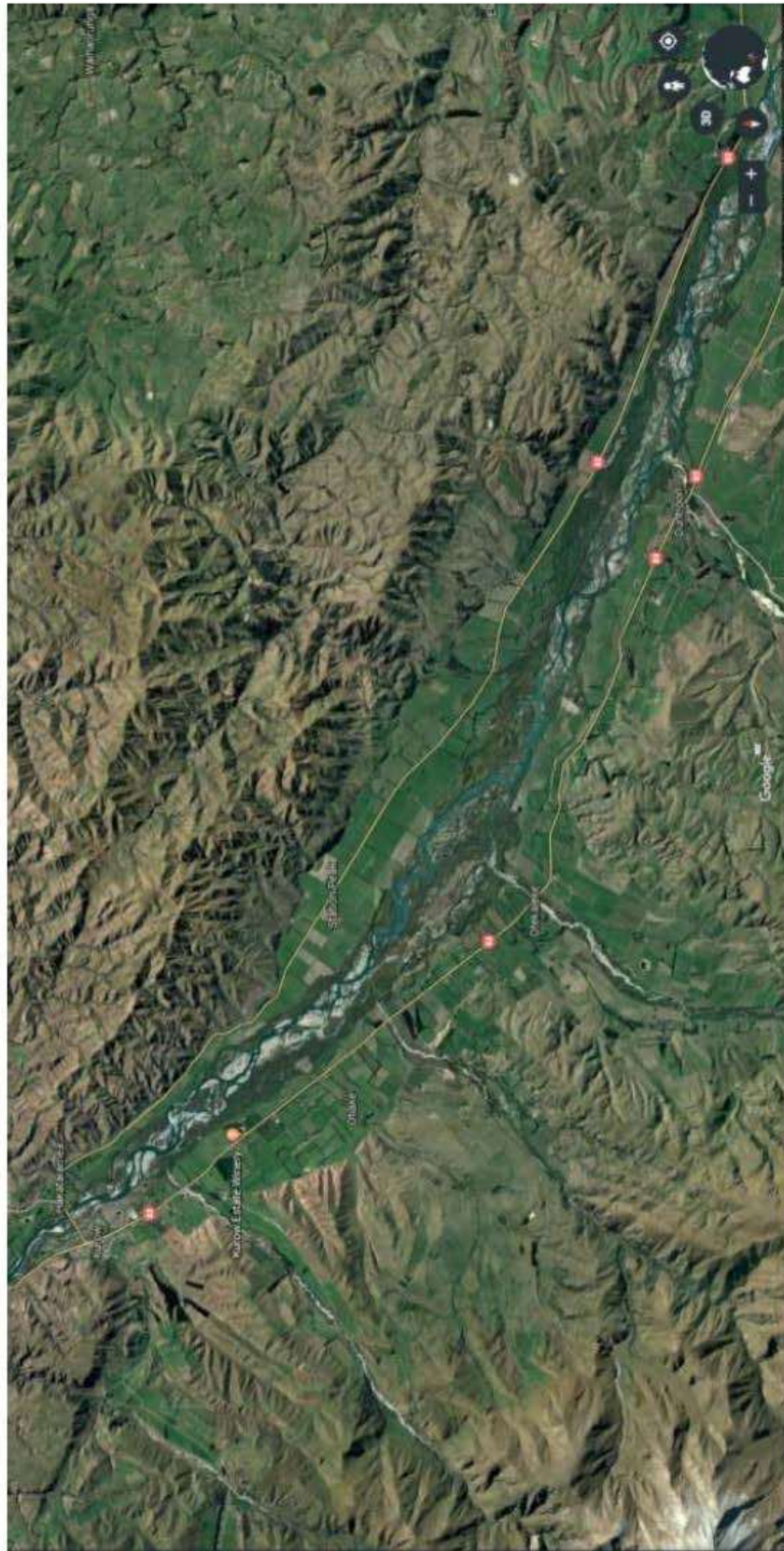
2. Come back to Zone Committees to:
 - confirm the reach;

- work with you to add your information;
 - identify any gaps; and
 - identify the need for any technical reports to commission specifically for this reach (e.g., cultural, ecological, a range of flood return periods, landscape etc)
3. Carry out any technical work and return to zone committees to discuss results.
 4. Complete a GAP analysis informed by technical work and consultation; and
 5. Give effect to any changes required - consider statutory plan change in 2019 and non-statutory options.
