We have 3 daughters who attend Papanui High School, and will in due course be looking for jobs, and attending sport practices. Eliminating the 107 & 108 bus routes is ridiculous. Yes, they mostly use the bus only during term time, but outside of school hours there is weekends, after school & holidays - all of which involve bus usage. We encourage them to use the bus whenever they can, as they are old enough to do so, and it is a safe way for them to travel (to/from school, to friends, to town to meet friends, to music lessons, to sports practise, to partake in CCC Events/Summertimes....)

Eliminating the routes would cause inconvenience for us (their parents) as we would have to organise other means of transport for our daughters to get to their appointments - & this could involve us having

to leave work early, or have another parent/grandparent/caregiver provide transport - putting cars on the road instead of using public transport.

Why don't ECAN combine 107 & 108 into an all encompassing route - to cover Willowbank, Northwood, Regents Park, & Casebrook? Half hourly buses (mini or otherwise) could run from 7-9am, hourly buses 10am - 2pm, half hourly resuming 2.30-6.30pm, then hourly again 7.30pm-11.30pm.

There is the new Highsted Development progressing its build & the Summerset Residential Village being built - both of which are adding to the wider Casebrook/Styx Mill number of residents. I believe a bus route would be a great draw card for the Summerset Village residents to use public transport while they can. And residents from the new subdivision would also.Using public transport is seen as a right in Christchurch. It helps communities come together - whether meeting at the local mall, or heading into town.

The ECAN newspaper delivered to (most/some of) our homes states that "Public transport is a key part of connecting communities and enabling work and social travel" HOW CAN THIS BE ACHIEVED IF YOU TAKE AWAY THE TWO MAIN SERVICES (107 & 108) WHICH CONNECT US TO OUR COMMUNITIES/WORK/SOCIAL TRAVEL???

Yes these 2 routes may not even run at 10% of the cost to run them; but other routes are achieving over 70% - swings and roundabouts (or in our case, little mini buses and big buses)

I hope that ECAN can think a little outside the square, & truly think about the current ratepayers in the area of 107 & 108 and our future ratepayers. We pay our rates and taxes, just like other areas, & we deserve to have our bus routes.
