You say in your Consultation on the long term plan that you are "Enabling a resilient, multi-modal transport system for the efficient movement of people and freight into, out of, and within the Canterbury region" but by cancelling bus route 107 you are doing the opposite.

With more shops opening in the city you are penalising the citizens of Casebrook by not having a bus route to take them to the city or Northlands for that fact where they would spend their money.

The Summerset Retirement Village that is presently being built will eventually have 260 homes, including two and three bedroom villas and serviced apartments but if you cancel the buses there will be no bus route for them.

This route could be alternated to sometimes go down Papanui Road to ensure that people could still get to Northlands if they wished.

This would combine all three routes and ensure that the public was still serviced, you had less cars on the road, and I believe would save some money by combining the three routes.
