I am concerned about ECan's approach to the health of our community and of our water supply, specifically in relation to the water bottling operation at the Silver Fern / Kaputone sites in Belfast, and especially the drilling of an additional bore ("ECan accused of 'bending the law' over consents for water bottling plants", The Press, 16 March 2018). Comments in the CCC LTP consultation document suggest the City Council has, um, washed their hands ("ECan controls the process for dealing with resource consent applications", and "We cannot regulate without central Government intervention"). What ability does ECan have to do anything other than facilitate the export of water? I don't see how bottling for export aligns with any of the outcomes listed in the LTP consultation document under the Freshwater Management priority (it's not community use, isn't healthy for the ecosystem, and has minimal economic benefit)?
