Can ECan please re-evaluate the farebox recovery policy and to start recognising public transport as an investment with numerous social benefits and long-term economic benefits, not to mention a crucial part of reducing transport-related carbon emissions.

I reject the proposed reduction to the maximum Total Mobility subsidy per vehicle trip from \$35 to \$30. Services for those with disabilities should not be cut unless viable alternatives are offered and until public transport is made more accessible to all.
