I firmly believe that the proposal for removing the six bus routes is undemocratic. I fear that we will be isolating the people who live out that way. People who are disabled, elderly, or incapable or too poor to drive a car/bike, should not be treated as inconsequential. Along the same vein, reducing the Total Mobility subsidy would be a disgrace without a viable alternative option for the people affected. We should be working on becoming a more inclusive city, and not excluding those who aren't "worth the money"; doing otherwise is undemocratic. Public transport should be available to all.

I would like to see more patronage data for these routes (perhaps they can be covered with a minivan-type arrangement, like in Lytellton). I also fear that fare increases will doom the bus network even more (we should encouraging people to use buses, not discouraging them!) and would appreciate some financial projections/calculations to be released to the public. Christchurch cannot be a modern city without a thriving public transport system. Companies, cities, and countries around the world are already shifting away from cars due to inefficiency and their costly carbon footprints. Christchurch should be at the forefront of this shift. Investing money in the bus system will have long-term benefits, so I hope we can see a greater push for bus patronage. I appreciate the work already done by the Metro Facebook/media team, and would love to see this increased.
