It is essential that ECan properly assess externalities such as health costs arising from the contamination of water, e.g. by nitrates from intensive agriculture. The intergenerational debt from due to the long term effects of water pollution must be considered. I am aware that nitrates may infiltrate under the Waimakariri river to pollute Christchurch water. The future costs of addressing this issue may be immense.

Call in all consents when a new minimum flow regime is set for a catchment, not when each consent is due for renewal. I would like to see more funds allocated for resource permit monitoring and enforcement, e.g. random compliance checking. This should apply to permitted activity farms as well as those of higher risk.

The Climate Change Integration programme needs more resourcing. We are rapidly reaching a point of no return to a benign climate and action required right now! The programme needs to focus on mitigation as well as adaptation.

Climate change action should be a prominent, stand-alone functional portfolio, not "hidden away" in the Hazards, Risk and Resilience portfolio where it is easily de-emphasised.

All ECan activities should be assessed for their effects on carbon emissions. ECan should also commence working on an inventory of emissions for the region.

ECan should be lobbying government for a requirement on local government to act on climate mitigation as well as adaptation. The Local Government Act requires local authorities to work for the wellbeing of their communities, therefore action on mitigation can be said to already be required.

More time should have been allowed by government for the recovery of bus patronage following the earthquake disruption. Only now are workers beginning to flood back into the central city. Cutting services now is premature and funding should be found to continue all current services. Increasing fares will just discourage people from transitioning back to public transport.

Use of public transport has numerous social and economic benefits and contributes to the vital goal of reducing transport-related carbon emissions. I would prefer if ECan could extend funding to support public transport without reducing services for a little longer, at least.

The bus routes identified for discontinuation provide service to quite remote locations (e.g. Spencerville and Rapaki) and discontinuation may severely inconvenience some people with no alternative means

of transport. I would like to see consideration given to a reduced service on these routes, rather than complete discontinuation. Even running just a couple of times each day may be sufficient to provide an adequate, low-cost service to those people with no alternative.

I disagree with reducing the maximum Total Mobility subsidy. If reducing the cap from \$35 to \$30 will only affect 3% of Total Mobility trips then the saving will be minor and not worth the impact on those who are probably least able to absorb the extra cost.
