I am very disappointed to read that one of the proposals ECAN is considering is to make a reduction in the subsidy to the Total Mobility Scheme from \$35 to \$30. People with disabilities already have a difficult time trying to make their overstretched resources go far enough to cover their expenses. Reducing this subsidy would mean people will have to find another \$10 per outing to be able to access the community. My thoughts are that ECAN should be supporting people with disabilities to be able to get out and about not impact negatively for this to happen.

There must be other areas within the ECAN scheme that can help towards reducing costs other than impacting on people with disabilities. I implore you to reconsider this option and consider other areas.

I am very disappointed to here that Ecan is proposing to reduce the subsidized portion of the Total Mobility scheme from \$35.00 per trip to \$30.00. Persons with disabilities are already on an over stretched budget and for some people this is another \$10 per outing that they are going to need to find from something else. Probably it will mean that they have to forgo food or heating to allow for this.

Can someone please explain to me how penalising people with disabilities is an effective cost saving alternative for ECAN as an organisation. My thoughts are that this has not necessarily been considered well and there will be other areas within ECAN that can be adjusted so people with enough issues in their lives do not have these impacted by this decision.
