Comments:

Canterbury has seen an enormous intensification of farming. As a result, our waterways are suffering immensely and our drinking water is contaminated with E-coli and/or other pollutants like nitrates;all detrimental to human health. We would like to see in ECan's Long Term Plan for 2018-2028 a stop of all farming intensification (e.g. conversions to dairy farming and conversions to intensive beef and sheep operations with centre pivot irrigation). ECan needs to oppose the planned new central water storage schemes Canterbury, like the Hurunui Water Project, - because more central water storage schemes will lead to more intensification of farming,because there is already an over-allocation of water in this area,because the public is already suffering under existing conditions (drinking water is unsafe to drink, swimming in rivers and streams has become a health risk, fishing is reduced and other recreational activities in and around water ways are not safe or possible anymore).

Secondly, ECan needs to work on a common definition of

"Good Management Practices" and publicise those. There needs to be considerably more effort in reducing N and P loss and nutrient-dense run-off from farms. More than the two proposed Land Management Advisors are needed "to support farmers in the uptake of Good Management Practices to enable the delivery of the CWMS nutrient targets". These advisors need to have management up-to-date scientific knowledge of fresh water management, soils and sustainable farming. Environmental knowledge and protection should be their Number 1 priority. Certain regulations for intensive farming operations (depending on farm size, stock numbers, soil type and climate) need to become mandatory: cow/ stock numbers might have to be reduced or wintering barns might have to put in to reduce pugging and nutrient run-off, effluent storage tanks will have to be upgraded to make use of the methane gas (a powerful greenhouse emission) instead of it going into the atmosphere. It should be mandatory like in Europe to allow effluent only be brought out on the farm in the growing season (not in the winter) when plants are able to take up and make use of the nutrients. Another measure would be for streams and waterways to be fenced and planted with suitable plants to take up nutrients, vary the flow, shade the stream and create a habitat for a variety of species.

Lastly, ECan's LTP is proposing "an increased focus on data across all portfolios (...). This data management and monitoring is key to measuring progress and being able to respond to change."

We disagree. While data gathering is good and necessary, it is very urgent now to put measures into action. At Te Waihora/Lake Ellesmere (as around Lake Taupo in the North Island) farmers have to adhere to strict management measures to reduce their N loss by 30% by 2022. While this is not even enough and not soon enough, in other areas farmers do not have to adhere to any mandatory nutrient targets.

Canterbury's Ararira-LII river is one of five catchments included in the Fonterra/DOC Living Water partnership. Phillip Musson who runs a dairy farm in that area and reduced his farm N run-off from 80kg/ha to 4 kg/ha proves that it is possible to reduce the Nitrogen loss much further. He also shows the it is possible to farm sustainably and still make a profit.

We would like to see Ecan put into the LTP:

Mandatory mitigation for conversions from traditionally farmed sheep and beef farms to intensive dairying or intensive beef or dairy cow grazing on feed lots with centre pivot irrigation. For centre pivot irrigation usually all the hedges get taken out. It needs to be mandatory to mitigate the loss of habitat for insects and birds by replanting other areas in natives and/or creating wetlands for biodiversity. Also, plantings along streams and waterways and fencing off those areas need to be made mandatory. Sediment run-off when converting and when cultivating land needs to be monitored and minimised because the fine particles can choke streams and lead to loss of habitat for insects and fish.
