5.1.1 FACILITATOR'S UPDATE

The Upper Waitaki Zone's Annual Report was presented to the Environment Canterbury Council yesterday and they were happy with it. An event called the Watershed Symposium is coming up on Monday, 9th April. Members were encouraged to attend.

5.1.2 REGIONAL UPDATE

Sandra Hamstead-Tipene reported that Upper Waitaki's swimming and recreational areas are ok and the regional committee was more concerned about other areas with lower quality water. She attempted to get the issue of freedom camping onto the agenda of the regional committee but was unsuccessful.

Discussion followed on the lack of visibility of LINZ staff at all meetings about freedom camping issues in the district.

Craig Dawson spoke about a regional, multi-level approach from central government to help solve some of the freedom camping issues, because councils have tried and have not been successful. The facilitator suggested inviting someone to the next meeting to speak. Matt Bayliss suggested inviting Jeremy Severenson. Barry Shepherd suggested inviting Bill Bayfield. John Wilkie raised the effects of freedom camping on mana kai (should this be mahinga kai?) and said the rules needed to be consistent nationally. It was noted there was no engagement between the zone committee and the conservation board. The facilitator was asked to invite conservation board members to the next meeting. Also a suggestion to invite members of the Mackenzie Trust and treat it like a workshop.

Facilitator Barbara Gilchrist will organise a workshop with stakeholders on these issues.

5.3 MATTERS UNDER ACTION

Totara Peak boat ramp issues – Matt Bayliss has taken the committee's views back to the owners of Totara Peak. The chairman requested a letter be written to LINZ to inform them of the need for maintenance on the boat ramp. Chris Eccleston said there were similar discussions underway in the Lower Waitaki zone committee area.

COMMITTEE RESOLUTION UPP/2018/8

That the facilitators of the Upper Waitaki and Lower Waitaki Water Zone committees work together to inform LINZ of the issues with boat ramps in both areas.

Omarama Stream Update – a meeting date has been set for the 19th April in the Omarama Hall.

Haldon Camp Trustees Update – Chris Eccleston has spoken to Stu Hessell who is a trustee. The current septic tanks are working fine and not being overloaded. Mr Hessell sees an issue with weed in the lake. Chris Eccleston is getting back to him regarding plans around weed clearance.

Update on Public Toilet at Ahuriri Bridge — Ian Guthrie (Gus) from the Department of Conservation addressed the committee regarding the DOC campground and toilet at Ahuriri Bridge. This has become a campground with too many campers. They have restricted the camping area with a fence, which has been partly successful. They want to build another toilet at Ahuriri Bridge but have not received funding at this stage. Discussion was held on whether to further restrict the area available for campers. This is one option but it is a complex issue. Gus ? said he picks up the rubbish at the site and people exaggerate the amount of human waste on the ground.

Discussion moved to the quality of the DOC toilet at the Poaka campground. Gus agreed another toilet is needed there. The chairman agreed that better facilities were needed at Ahuriri and Poaka because of the numbers using them. Gus was asked if there was anything the zone committee could do to support his case for more toilets and he said he could not think of anything.

The meeting adjourned for morning tea at 10.57am and reconvened at 11.16am.

5.4 BRIDGE PROJECT

Tania Harris, Environment Canterbury, introduced the Bridge Project to the committee. The project is about finding the boundaries of the braided river beds. Maps are attached to the agenda. These three areas are a starting point and she asked if there were any more. It was agreed

that further discussion was needed between Tania Harris and iwi representatives on the eel fishery in the Ahuriri River. The committee agreed that the Ahuriri River was a priority, and also mentioned the Tekapo River and Tasman River. Tania Harris will come back to the committee at a later date.

5.5 UPDATED CONTROL PLAN MAPS FOR CIRCULATION TO MEMBERS

This information was noted.

5.6 COMMUNICATIONS AND GENERAL BUSINESS

Communications – Kate Doran, Environment Canterbury, gave a power point presentation on communications.

She showed the committee a sign outlining the Willowburn biodiversity project. This will be erected near the Alps2Ocean track. Discussion was held on local infographic signs and whether they could be used on social media as well as community noticeboards. The committee agreed that she was on the right track.

Matt Bayliss mentioned the need for community information regarding the elder control project signed off on at the last meeting. He would like something in the Twizel Update.

Discussion was held on whether the zone would like its own Facebook page. This was not considered a priority.

Barbara Gilchrist suggested organising a public event like a barbeque at the start of the summer season to promote the work of the zone committee. Also noted that attendance at local events would be a good idea.

Barbara Gilchrist asked what information the committee wanted to hear about effluent next month. Feedback - Trends in effluent. Farm plan projects. How to explain the need for a farm plan to the rest of the farm community. Explaining the sewerage disposal systems. District plan rules for developers not connected to urban schemes. Where is the effluent going at Mount Cook?

The Canal Clean-up 2018 is happening this year in May. Member Matthew Bayliss will forward an email to Barbara Gilchrist for distribution to the committee.

The Meeting closed at 12.26pm.
