SUBMISSION ON PROPOSED AMENDMENTS TO THE CANTERBURY REGIONAL COUNCIL FLOOD PROTECTION AND DRAINAGE BYLAW 2013

To Environment Canterbury

Name of submitter: Erralyn Farm Limited (*Erralyn*)

- This is a submission on the Proposed Amendments to the Canterbury Regional Council Flood Protection and Drainage Bylaw 2013 (the *Proposal*).
- 2 Erralyn could not gain an advantage in trade competition through this submission.
- 3 Erralyn wishes to be heard in support of the submission.
- 4 Erralyn's submission on the Proposal relates specifically to the flood protection vegetation line in Map 37, Schedule 1 of the Proposal.

Introduction

- 5 Erralyn is generally supportive of the Proposal, subject to the amendment of the flood protection vegetation line (to the extent required) identified below.
- A summary of Erralyn's farming operations and reasons for Erralyn's submission are set out below.

Background to Erralyn's farming operations

- Frralyn has been farming the land shown in blue in **Figure 1** for a large number of years now (the *Property*). The Property is located on Acton Road, adjacent to the Rakaia River.
- 8 The property is subject to existing water rights for irrigation purposes.
- In May 2013, Erralyn acquired resource consent CRC135495 which authorises the use of a centre-pivot irrigator over an area in the southern part of the Property.
- 10 In January 2018, Erralyn acquired the following resource consents:
 - 10.1 CRC167731 which authorises Erralyn to undertake flood protection works within the bed of the Rakaia river (including groyne construction and the disturbance of vegetation); and
 - 10.2 CRC167732 which authorises Erralyn to divert river braids in association with carrying out the flood protection works under CRC167731.
- Erralyn has a particular interest in the location of the flood protection vegetation line as identified in the Flood Protection and Drainage Bylaw 2013 (the *Bylaw*) and the Proposal. The flood protection vegetation line is shown as the pink line in **Figure 1** below.

12 Erralyn seeks to ensure that the location of the flood protection vegetation line in the Proposal does not adversely affect the resource consents Erralyn currently holds or the existing and historic uses on the Property.



Figure 1: The approximate outline of the Erralyn Farm (and associated property) is shown in blue. The flood protection vegetation line from the Bylaw is shown in pink.

13 Erralyn accordingly seeks that the flood protection vegetation line in the Proposal be amended to more accurately describe the true vegetation line which is maintained by ECan for the purposes of flood protection – and that it reflect existing authorisations and the Land and Water Regional Plan rules and definitions.
