

<b>Name of holder:</b> New Brighton Power Boat Club
<b>Period:</b> From: 09/10/2016 to 07/05/17 and then an ongoing 12 days per calendar year until the current bylaw is reviewed or revoked ; or Until revoked by the Harbourmaster.
<b>Reserved Area:</b> Lake Forsyth
<b>Map attached:</b> No
<b>Purpose:</b> To allow powerboat racing on Lake Forsyth and permit racing boats to exceed the 5 knot speed limit within 200 metres of the shore, within 50 metres of another vessel.
<b>Reservation:</b> No vessel shall navigate within the Reserved Area as listed above except with the express permission of, and in a manner explicitly approved by, the certificate holder or his delegate.
<b>Conditions:</b>
<b>Publication of notice of Reservation:</b> Notification to known affected groups; notifications on appropriate websites and social media; notices at known boat ramps and key access points.
<b>Notice of Reservation to be:</b> Displayed at: <b>As above.</b> Displayed by: <b>Rob Knoef (or delegate).</b> Removed by: <b>Rob Knoef (or delegate); or the Harbourmaster</b>
<b>A copy of the Temporary Reservation Certificate to be carried by:</b> <b>The safety patrol vessel.</b>
<b>Safety conditions:</b> The Harbourmaster is to be notified within 30 days prior to the start of each racing year the dates required for the Lake Forsythe to be closed for racing via the <a href="mailto:harbourmaster@ecan.govt.nz">harbourmaster@ecan.govt.nz</a> The safety of all vessels is to be checked and approved by scrutineers on each race or practice day, with a scrutineering form completed and retained. Driver's briefings are to be conducted before any races or practices commence. Two fully equipped rescue craft are to be on the water during each event, maned by experienced rescue crews. The races are to be run under the rules of the New Zealand Power Boat Association and comply with the association's safety criteria. A copy of this certificate is to be held by the race controller on site.
<b>Temporary Reservation shall not take effect if:</b> <b>Conditions above are not met.</b>
