Ecological Significance, information about soils and erosion, and queried how much information related to water systems, freshwater and biodiversity.

Olivia Smith will circulate the consultation documents for the Committee's information and options available. Zone Committee members may submit as individuals. Feedback from the Committee should be sought earlier in the process in future. A decision will be made about the Committee's input at its next meeting.

8. Facilitator's Update

Committee Comment

- 1. Banks Peninsula Conservation Trust Workshop Pam advised she had attended this workshop on 4 October, and that a number of organisations, including the Department of Conservation, would form a Port Hills Biodiversity Hub and a Management Plan, that would include weeds and pests.
- 2. The following item was added to the Upcoming Events a stormwater superhero workshop held at Environment Canterbury on 17 and 18 October.
- 3. At the bottom of page 17, the Facilitator noted that the science team will also report back in November on swimming water quality at coastal sites in Pigeon Bay.
- 4. **Action Plan** –The Committee members had a brief discussion on Mahinga kai.
- 5. Discussion was held about:
 - 2(7) Share in depth annual water quality and ecosystem health monitoring results and relevant research with the Banks Peninsula community. The Zone Committee suggested seeking further information to understand the causes and effects associated with change.
 - 3(11) Encourage landowners to develop alternative/new stock water sources. The Zone Committee agreed to add 11(a) Environmental flows.

4(12) IMS biodiversity fund is strategically allocated and celebrated. This should be amended to read "IMS biodiversity fund is strategically allocated and progress celebrated."

- 6. Olivia will circulate information from the Long Term Plan about upcoming sub-regional processes.
- 7. Discussion was held about what support the Zone Committee could provide to help address issues of turbidity with the Duvauchelle community water supply. It was suggested that some planting upstream may be beneficial. Pam is to speak with some community members regarding the issue.
- 8. Discussion was held about Gina's news article and where this was advertised, e.g. the Akaroa Mail and Bay Harbour News. Gina will send her thoughts in an article under her name, for publishing. The Zone Committee members noted this was an amazing job done by Gina with input from Ian.
- 9. lan advised that through the Whakaraupo project schools were given projects to complete, including Diamond Harbour School. He advised that the project would be launched next Thursday 25 October.

9. Environment Canterbury Zone Team Update

Committee Comment

Gill Jenkins spoke to her report on the Environment Canterbury Zone Team update. She advised that the FEP workshop at Okains Bay would be delayed until a Land Management Advisor was employed early in the New Year.

The Committee discussed the number of workshops to be held. They expressed their frustration that a lot of planning was carried out regarding the Okains Bay workshop and that it was one of their priorities that has not come together, and their disappointment that one of the Committee's targets will not be met, and its goal not achieved this year.

They agreed 3.1 should be reworded so that it did not suggest Beef and Lamb had delayed the workshop.

Olivia Smith advised she will circulate the paper previously prepared by Ian which lists the priority catchments for FEP workshops. This can be used to inform the Committee decisions for 2019 workshops.

FEP workshops should be considered for a number of areas, as listed:

Port Levy, Whakaraupo, Purau, parts of Wairewa and stream, outer bays, southern bays, Le Bons, Little Akaloa, Okains Bay, Wainui, Barrys Bay, the whole of Akaroa and Teddington.

The issue of Okains Bay drainage was raised and discussed. The Committee agreed to invite ECan river engineers, CCC staff and also suggested it could be useful for Justin Cope or Lesley Bolton Ritchie to attend. This would provide the Committee with advice and understanding on this matter.

Early 2019 the Committee will receive an update on the Coastal Plan and on research to help inform the Plan.

Paragraph 3.3 – it was noted that the first meeting for 2019 will be held at Wairewa, to include a site visit to the bank stabilisation programme area.

10. Update on the Significant Ecological Sites Programme and Christchurch City Council Biodiversity Fund

Committee Comment

Laura Molles spoke to her report on the Significant Ecological Sites Programme and Christchurch City Council's Biodiversity Fund.

Discussion was held about FEPs and there was support for FEPs incorporated into the Sites of Ecological Significance. Ian advised that farmers felt comfortable with using the FEP process when this was trialled in Pigeon Bay but there had been no follow up from that.

Environment Canterbury and the City Council need to meet and discuss who is responsible regarding ecological matters and in relation to education/communication/relationship building. The FEPs require resourcing and commitment, with follow up and surveys carried out.

Laura requested feedback from the Committee via email, direct meeting, or by telephone on landowners needs.

Pam noted that this needed to address weeds and pests, goats, possums, deer and pigs also.

- (b) the correct Maori names are used.

12. Fish Passage in Stormwater Structures in Cass Bay and Cosair Bay Committee Comment

Discussion was held about fish passage. June Swindells advised of Rūnanga concerns about fish passage in two culverts in Rāpaki and advised that it would be appreciated if these could be investigated.

1. Seek technical advice on fish passage and culverts, in particular for the three new stormwater structures in Cass Bay and Cosair Bay, including two at Rāpaki and how culverts which do not accommodate migratory fish are remediated.

13. Banks Peninsula Summer Water Efficiency Campaign

Committee Comment

Discussion was held about the Christchurch City Council's focus on urban water with messaging, although not targeted, included about the Banks Peninsula area. The Committee agreed on the following messages they would want to convey over the summer:

- Conserving water
- Target the messaging at children
- Check taps/pipes for leaks

The following points were noted during the discussion:

- Take information on these messages to events, such as the ShakeOut or for the Christmas holidays
- Remind the Council that the reticulated Banks Peninsula communities, including the Harbour Basin, need targeted messaging
- Reticulated supplies, there is an opportunity to promote messaging to the rural area, e.g. holiday makers
- "It is not just townies who should be thinking about water conservation, it is everyone"
- Zone Committee members can access the City Council's Newsline at https://www.ccc.govt.nz/news-and-events/newsline/, as well as share activities with others
- a suggestion about the Council making it easier for Banks Peninsula residents to have rainwater tanks
- Have a stall at the shows such as the Duvauchelle or Little River Shows
