4. Deputations by Appointment

4.1 Akaroa Area School representatives – Advocating for our streams

Three Year 13 students, Julia, Blake and Anthony, supported by teacher, Garry Brittenden, provided an illustrated overview of their project including what they did and why. They surveyed seven Banks Peninsula Streams. The group discussed their key research findings including the advantages of riparian plants.

In thanking the students, the Chair recommended that information on the "CWMS Refresh" should be passed on to the school.

- 7. Banks Peninsula Zone Monitoring Results 2017-2018 Committee Comment

Dr Tina Bayer, Surface Water Scientist, in addition to her written report, provided an illustrated update on Banks Peninsula's Water Quality and Ecosystem health.

There was discussion following the presentation and key points included::

- Concern about why stream sites with poor results were getting worse
- The importance of using mahinga kai as an indicator for monitoring the health of Banks Peninsula streams.
- Question regarding the potential source of phosphorous, given that farming stock rates have not increased in the last 10 years.
- The need for further information about 'tunnel gully' erosion.

Dr Tim Davie, Chief Scientist, advised that there are four key drivers of poor ecosystem health and these all relate to habitat:

- Sediment
- Temperature
- Shading
- Water Quantity

It was noted that in Te Roto o Wairewa Lake Forsyth there is a significant declining trend in Total Phosphorous (TP) and Total Nitrogen (TN). However trends in chlorophyll a and turbidity were not significant.
