Swing Mooring Charges I strongly object to the proposed increase in charges for swing moorings. I own and maintain a swing mooring in Akaroa Harbour and while I accept ECAN may find the cost of administration to exceed the present fees charged, I believe that it is incumbent on ECAN to manage its activities within the current charges. I do not accept that the administration of a mooring facility requires such an overlay of supervision. Safety is assured through the annual inspection by ECAN registered contractors for which I pay significant charges. These inspections are triggered by me on a "bring-up" basis with the contractor who completes the inspection and provides a report which is forwarded to ECAN. There is no need to write me a letter of reminder which is the only contact I have with ECAN. Being asked to pay \$230 pa for this service is simply outrageous. I get complementary reminders from various service enterprises - WoF, REGO for example - from time to time as a courtesy. Why should I entertain a charge for this from ECAN? The current charge of \$115 pa for record keeping is in my opinion, more than enough.
