This long standing policy reflects the public good nature of biodiversity. While the proposed programme is primarily for biodiversity, I want to ensure that it continues to be community led and I believe that having a targeted rate component provides a stronger basis for this. I also recognise that funding this initiative entirely from general rates may lead other parts of the region to ask for similar support without the same local commitment that has been demonstrated through this initiative and the CIP programme. For these reasons, I accept the proposed 50:50 split between general and targeted rates as a pragmatic solution in the meantime that allows local community aspirations to be met while also acknowledging the wider benefits of biodiversity.
