We wish to be heard in support of this submission

Allied Concrete currently supplies some 180,000m³ of ready mixed concrete annually into the Christchurch market through its plants at McAlpine St., Mclean's Island (Ashby's Ready Mixed) and Rangiora. At the height of the earthquake rebuild we supplied up to 330,000m³ annually.

This concrete is used in all aspects of construction; residential floors, foundations and driveways, commercial construction of all kinds and infrastructure both above and in the ground. As such concrete is integral to the growth and development of the city.

Every cubic meter of concrete requires approximately 2 tonnes of high quality aggregates and

Allied Concrete currently purchases around one third of its Christchurch sand and aggregate requirements from Fulton Hogan's Pound Road Quarry which is approaching the end of its resource and operating life.

Our reasons for supporting this application are:

- 1. The Roydon Quarry will be a direct replacement for the Pound Road quarry and secure the ongoing, economic supply of aggregates to our McAlpine St plant.
- 2. The quarry will provide for the continuation of supply of high-quality aggregates that are essential for the concrete production required to meet growth predictions for Christchurch and surrounds.
- 3. Christchurch has an ongoing requirement to improve and develop its infrastructure. Both concrete and quality aggregates are needed to meet this requirement.
- 4. That most truck traffic associated with the quarry is expected to go directly on to SH1 and will benefit the traffic flows and safety on rural and minor roads in the area.
- 5. Fulton Hogan have proven history as a responsible operator of quarries, who respect and care for the environment.
- 6. They also have a record of minimising the impact of their operations on their neighbours by their actions including dust suppression, noise control and minimising visual impact of their operations with landscaping etc..
- 7. Furthermore, they have the financial resources to ensure that the site is developed and run as a quarry should be.
