- 2. The reasons for making my submission are: (state in summary the nature of your submission, giving reasons)
 - I live in Dunedin, but I am a user of the Buddhist temple at Maddisons Road, Rolleston which is situated in the vicinity of the land use site proposed by above application. Over the last 17 years, I am one of the many beneficiaries of the services delivered by this Sri Lankan temple such as meditation, religious, and counselling programmes offered to Buddhists as well as to non-Buddhists. It is the only such temple in the entire South Island.
 - Buddhist temples require quiet and calm environment for its activities. We spent lot of money
 and effort to transform previously farmland into a peaceful and quiet environment. This
 environment is currently used by residential and visiting monks, and other devotees, to
 practice meditation and mindfulness. I am strongly objecting to the proposed Roydon quarry
 as it completely destroys that environment.
 - We are in the process of transforming this temple into a self-contained complex by creating more sites suitable for sitting and walking meditation for short-term and long-term users, building meeting rooms/halls etc, all within rural/vegetation environment, which is essential for mindfulness meditations. All our activities require quietness, calmness, and peacefulness in the environment. We selected current location for this temple for those qualities. Sound, traffic, and dust generated by proposed project will turn that environment into completely opposite. It is not possible to relocate this temple if the proposal goes ahead.
 - Proposed quarry is a safety issue for the devotees, not only those from Christchurch but also
 those coming from various towns in the South Island as far as Invercargill, for its daily,
 weekly, monthly, and yearly activities. This is in addition to the safety threat for the
 Christchurch children attending the religious school, mindfulness programme, and language
 centre of the temple.
 - We obtain water for all the activities of the temple using a well. Quality and quantity of this water resource will definitely be affected by the proposed project. This will make we cannot function as a temple in this location anymore.
