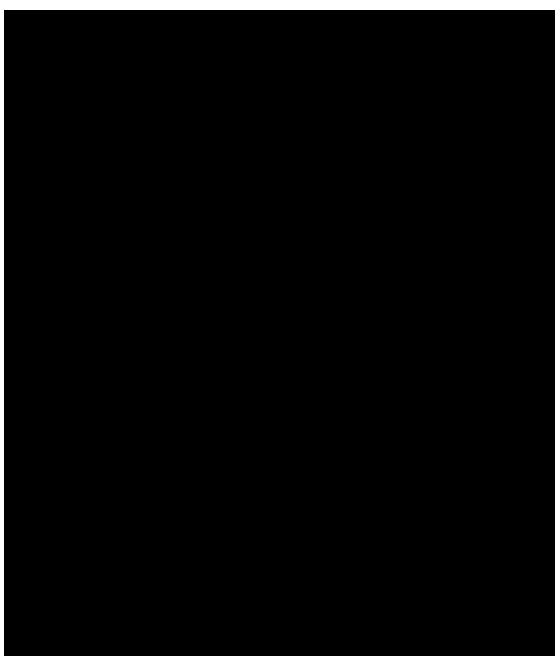

Reasons comment:

Noise Pollution - They are requesting a 24 hour operation. Their site is within 700 metres of a residential area. This will cause noise when residents are trying to enjoy their evening and will disrupt sleeping. Light Pollution - Again, the proposed quarry is within 700 metres of residential areas. Residents will no longer be able to enjoy the night sky and stars due to the required light Fulton Hogan would require in a 24 hour operation. Dust - A quarry will create dust in the environment and settle on residents' properties. In addition, it will settle on our solar panels. There is also a real threat of individuals getting silicosis. The Council has a duty of care not to subject people to potential harm. Traffic - Dawsons & Jones Road is one of Canterbury's worst intersections. There has been numerous collisions resulting in death and major injuries. Additional traffic will only make this situation worse. In addition to that, additional heavy traffic on Jones Road will worsen the surface of the road thereby increasing the risk for residents of Templeton. Water - Canterbury's water supply is currently under stress. If water is allowed to be removed directly from the aquifers or water leached into this resource, the future of the resource will be put in danger.

Consent comment:

I wish the Council does not approve the Fulton Hogan Quarry however, if it is, then the following conditions are recommended; The quarry only operate in the hours of 6am to 6pm. to reduce noise and light pollution. No Fulton Hogan traffic be allowed on Jones Road between Dawsons and Pound road. No water be leached in the aquifers A full boarder of trees of at least 6 metres in height be planted to cut down noise, light and dust.
