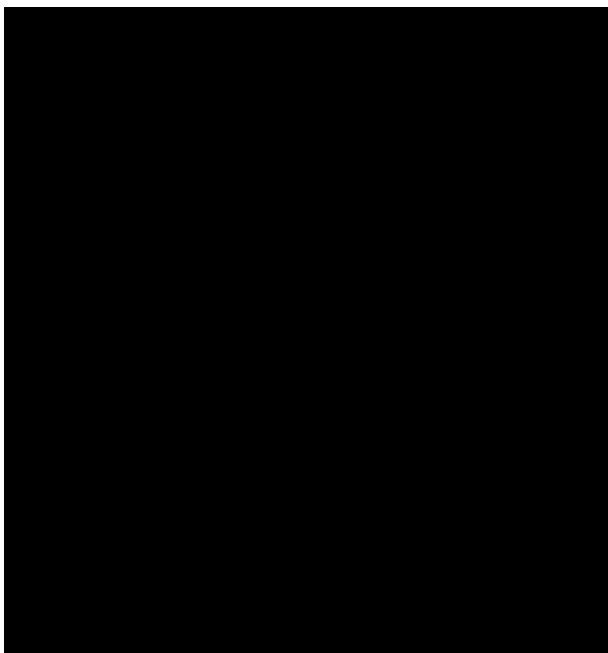

Submission on publicly notified application for resource consent.

**2. The reasons for making my submission are: (*state in summary the nature of your submission, giving reasons*)**

I wish to object to the application as a whole and feel very strongly that the application in its entirety should be declined.

We have been calling Templeton home for over 10 years. I always wanted my two girls to grow up in one place where we can make lasting memories. And that is what we have done. It is a unique village with special character. A quiet, friendly and peaceful neighbourhood. I can't wish for a better environment to have raised my girls in.

The adverse effects of the proposed quarry will definitely more than minor. The likely hood of adverse effects resulting from the activity is high with a large magnitude of the effects. Specifically (but not limited to):

### **3. Dust**

- Health Effects
  - No dust beyond the site boundary. Not sometimes, not for short bursts, not below certain levels. No dust, never.
- Nuisance
  - Environmental character of the area

  - Severity and significance will be more than minor.
  - Dust deposits inside the house and soiling of the outside.
  - Increased requirement for cleaning
  - Site preparation and bunds
  - Paved and unpaved surfaces
  - Wind-blown dust from exposed surfaces

- We live in a wonderful quiet environment at the moment. Apart from sporadic noise coming from a train passing or a plane flying over we have no constant, ongoing noise in the area.
- “Best practicable option” will be to prevent any noise seeing that it is a sensitive receiving environment.
- The closest residents living in a rural environment are entitled to a quieter lifestyle.
- Noise from the proposed quarry will be intrusive and particularly destructive of the amenity.
- The change from rural to industrial will be particularly significant.
