## **Jodie Eagar**



The reasons for making my submission are: (state in summary the nature of your submission, giving reasons)

l have been living in Templeton for close to 11 years. I started year 3 at Templeton Primary and loved every moment. I take a lot of pride in my school and my community and was involved in a variety of local groups.

I've learned to drive over the last two years and recently got my full licence. Something I am very proud of. I did however learn very fast how dangerous our roads are and how I must be aware of everybody else around me. This newly found freedom is the main reason I am opposing the application in its entirety.

It is difficult enough getting around in traffic the way it currently is. I can't begin to imagine what it will be like with an extra 1,500 heavy vehicles on our road. Trucks and trailers will be coming and going on Main South Road making access from Kirk Road impossible. (It is difficult and dangerous enough as it is now) There will be delays in my travel times and an added concern about safety.

I visit my grandparents in Rolleston regularly. With it being so dangerous to gain access to Main South Road from Kirk Road I travel down Jones Road most of the time. Mom tried to explain the proposed Roundabout that the applicant wants to put in at the intersection of Dawsons Road and Jones Road. We understand that option one is out of the question as they will not be able to use the Christchurch City Council Land. Which leaves option two where the applicant will have to make use of their own land. I have not seen any roundabouts looking quite like that anywhere. How will that affect me and what will it be like sharing such an awkward roundabout with so many heavy vehicles? Even worse if those vehicles are pulling trailers behind them. Once I have made it past the roundabout, I will be faced with those trucks entering and exiting the proposed property. How will this affect me? Will I be safe, and will it increase my travel time to my grandparents? From what I have seen when a truck and car collide, it is always the person in the car that comes of the worst. That is if they survive.

Being a student, I don't have money to spend on my car if it gets damaged by stones coming of these big trucks. I usually try to keep my distance but that is not always possible and will only get worse as they introduce more trucks to our roads. As a young driver my access payments are pretty steep and insurance cover only one windscreen replacement a year.

I have seen what damage the heavy vehicles do to Kirk Road and Waterholes Road. The potholes will do a lot of damage to my tiny car. She's not built for 'off-road' conditions.

Since the earthquakes we have had to live with constant roadworks. At some stage after the changes and improvements to SH1 is done this will finish up. It will be horrible if the road works never stop because of the constant damage caused by the heavy vehicles.

I also spend a lot of time walking our dog or going for runs on the roads around the proposed site. I can't help but be concerned about how I will safely cross the road at the intersection of Jones and Dawsons Road. I also feel that it is not possible to prevent dust from leaving the site boundary 100%

of the time. What if it is just that time that the applicant can't stop the dust and I am the one walking in the dust?

There is also the concern of what it will be like walking or running down a road with that many heavy vehicle movements on it. The noise and vibrations will affect my sense of enjoyment in what should be a rural environment.

The machinery used by quarry companies are very big and loud. Moving around the area the effect of the increased and constant noise will be more than minor.

I have been enjoying my outdoor activities around Templeton for many years. It is not right for a business to came and change everything affecting us in such a way that we all need to change our lifestyles.

Part of my enjoyment is the open, flat landscapes and the fact that I can see all the way to the Alps. If the applicant put 15m wide and 3m high bunds with large plantings all around the boundary it will change the landscape that I love and value away.

We can sit and look at the stars at night. There is not a lot of light around now. Introducing lighting on such a big site will spoil another special thing for us.

Being only 17 at the moment I have my whole life ahead of me. Looking after the environment we live in is a high priority as I want to enjoy the resources for many years to come. The duration of this activity on such a large site will affect us for decades to come. We already see how hard and even impossible it is to reverse the damage already done to the environment. We can't afford to get this wrong.
