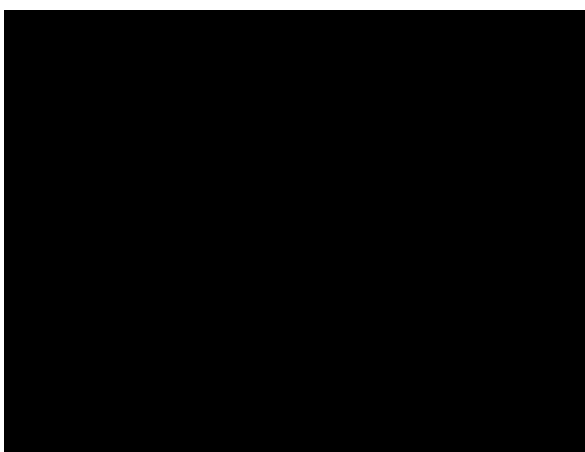

Reasons comment:

Reasons for opposing are: I do not want to see additional traffic through the Templeton Community. There is already a heavy flow of thoroughfare traffic which is dangerous to our community. I often walk Railway Terrace and witness almost daily heavy vehicles crossing the centre line, in particular on the bend where Jones Road meets Railway Terrace. On one occasion recently a truck lost part of its load of rocks on the corner. One would assume he was travelling too fast or had an unsecured load. When approached he said he had just come from the Miners Road Quarry. It is understood this was a contractor and not a Fulton Hogan Truck. There is no way Fulton Hogan can guarantee this situation is not to re-occur. The nuisance of dust and noise and the impact this will have on me and my family is of great concern. As a home owner we have the right to enjoyment of our land/home. This will possibly be jeopardized by constant dust, noise and vibrations of heavy vehicles. Water contamination. I would hate to see the quality of our water change. We have recently had the addition of chlorine to our water and at times this has made it impossible for us to drink. There are no benefits of having the Roydon quarry so close to me or my family. I believe the potential noise, air pollution, water contamination, and additional traffic will cause an unhealthy nuisance and loss of rights to enjoy our home/land.

Consent comment:

Should consent be granted I would like to see a condition applied that no heavy vehicles are allowed to travel through the main residential area of Templeton. Works which create any level of noise should be limited to so many hours per year, similar to those of the Ruapuna Speedway. Restriction on dust. Works that create dust should not be allowed during months where there is a water shortage (i.e Summer) as it would be impossible to keep the dust down with minimal water.
