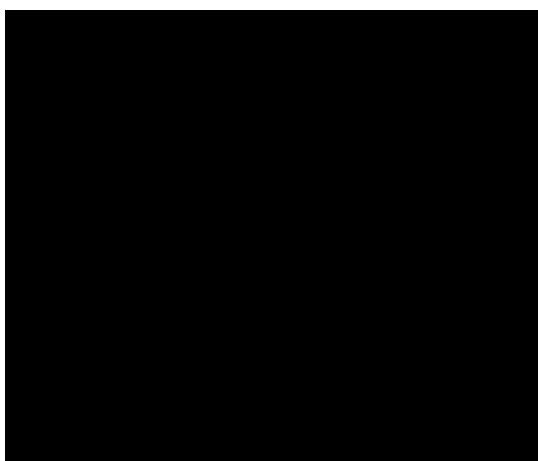

Reasons comment:

I have a number of concerns regarding this Quarry. They are: 1. The effect on the environment and surrounding areas - due to the noise of the numerous truck activity, pollution due to the numerous truck activity (both in vehicle pollution, and environmental pollution such as dust), and the increased danger on the roads. The roads around the proposed quarry area are already quite high in crashes and dangerous, the increased trucks and traffic on these roads is quite concerning, especially around the school area. 2. The effect that this could have on ours, and our subdivisions water. We have our own well water system, and I am very concerned this will affect our water due to the depth this consent is considering. 3. Increased dust and pollution in the air, most concerning the silica dust which can affect health. This area is prone to high wind zones, which will spread this dust even further. The health concerns I have include not being able to go outside with the kids due to increased dust and health concerns (and I the reason we bought a larger land property in the first place was so the kids could have a large area outside to play in), an increase in asthma attacks which they are both prone to, and the long term effects this silica dust can cause. 4. The mental (and possible financial) stress this will put ourselves, and others in, if this quarry were to go ahead. We would be very concerned, as will hundreds others, if this quarry were to go ahead due to the reasons listed above, and we would have to seriously consider if it would be in the best interests of our children to stay where we are, taking the above factors in, or to have to relocate, and in turn disrupt their home life, school and friends to ensure their health and safety.
