2. The reasons for making my submission are: *(state in summary the nature of your submission, giving reasons)*

My family lives in Christchurch but we regularly attend religious and meditation programmes at the Samadhi Vihara, 358 Maddisons Road in Rolleston.

Samadhi Vihara is a place of worship for those of the Buddhist faith who come to pray and to pay homage to the Buddha. It is a Meditation Centre, a place where people gather to learn and to practice meditation. The Samadhi Vihara is also the center of activity for Sri Lankan Buddhists living in the greater Canterbury region and the South Island, for both religious and cultural activities,

Noise: Noise from site preparation and Construction emanating from the quarry site, Continuous operation of machinery at the quarry, Noise from heavy trucks travelling to and fro to the quarry

Dust: Dust from quarry operation, Dust from trucks as they travel down narrow roads, Impact on health of children, elderly

Water contamination: from washing aggregates, washing trucks, Dust suppression.

Hours of operation of the quarry: 6am to 6pm daily is too long for people to endure. When this is increased at certain periods of the year to 10pm, people will have to suffer sleep disturbances in addition to continuous noise through the day including weekends.

3. I wish the consent authority to make the following decision: *(give details, including the general nature of any conditions sought)*

I want the authorities to **DECLINE** the application from Fulton Hogan and **NOT GRANT** consent for a quarry on the site bounded by Dawsons, Curragh, Maddisons and Johns Road.


I would like the following conditions imposed if consent is given:

Hours of operation: Reduce Quarry operation hours and only allow them to work on weekdays Monday to Friday from 7am to 6pm. Quarry should not be operating during the weekends or Public Holidays. Religious programmes and meditation programmes are usually scheduled for the weekends and quarry operations will make it very difficult for us to carry out our normal activities at the temple. Quarry should stop work when the temple organizes meditation retreats and other special religious and cultural programmes.

Truck Movements: Reduce truck movements to and from the quarry to 1000 per day. Truck operations to cease between 6pm and 7am in the weekdays. No truck movements to be allowed in the weekends. Trucks should be covered to prevent dispersal of dust while in transit.

Fulton Hogan must ensure that there are no truck movements on Maddisons Road. At any time.
