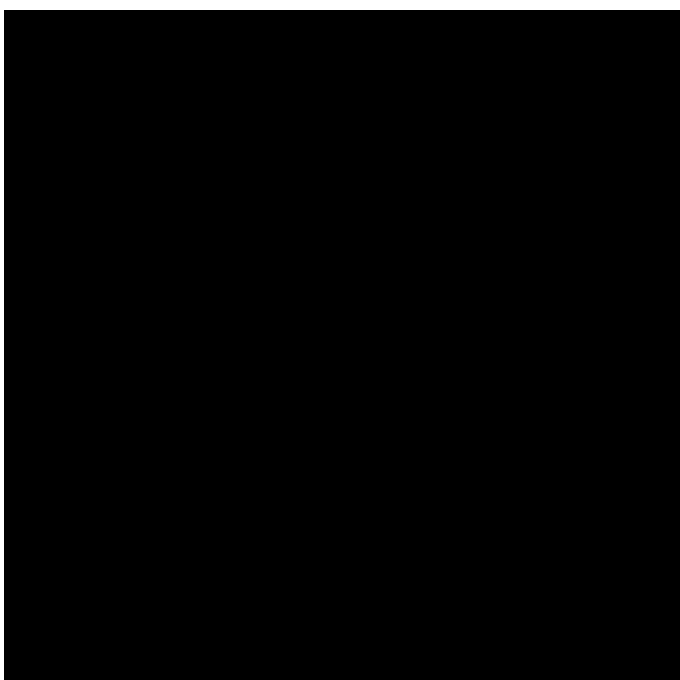



Reasons comment:

I have been a resident of Weedons for around 13 years. I run a business from home and am very concerned about the impact of this quarry on both my property, health, lifestyle and business. I selected this property due to the close proximity to both Christchurch, Selwyn, and the Main South Highway, and am seriously concerned about the possibility of a quarry opening and operating so close to all three. I wish to speak at the hearing and raise my concerns in person. My concerns are outlined below. I will expand on each of them at the hearing with supporting documentation. *Traffic/transport: quantity of vehicle movements, the noise, the infrastructure, routes, roading and the impact this will all have on our suburb, including cleanliness of trucks and covering of loads. *Potential site selection issues. *Water: including quantity to be used, monitoring, effectiveness of operation, the impact on our local and extended wells and aquifers, water source and replenishment, and water quality in every aspect to include our local wells and water races. *Dust: The quantity, classification, monitoring and composition of dust, and the affect it will have on our health, our land, our vehicles, our quality of life and lifestyle, and our water, to include the nuisance affect of same. *Noise and vibration and the impact this operation would have on our homes, our land, and our quality of life and lifestyle due to both. *The health effects of quarry pollution on all local residents, stock and wildlife, to include dust, noise, traffic, air quality and water/water quality. *Visual impact of the site on the local landscape. *The impact this operation would have on local amenities, local businesses and local growth and infrastructure as well as local road users. *The environmental impact on our water, land, and local amenities and businesses. *Compliance by the operator, enforcement by the councils (lack of both). *Rehabilitation of the land to include depth, materials to be used, and time frame for same. *The lack of current up to date robust research and data to support their application. *The cummalative negative affects of this operation on our lives, health, properties, roads, lifestyles, amenities, local growth and businesses. *Safety factors to include roads, road users and traffic; health and wellbeing, including respiratory, physical, physiological and emotional wellbeing of local residents and visitors. *The proximity of the site to the local International airport, Main Southern highway, railway line, local schools and townships, and the issues this raises. *The proximaty of quarry operations to local properties, including setbacks, bunds and shelterbelts.



Consent comment:

I do not wish this quarry application to be approved in any way, but if approval is granted I do have a list of conditions which I would like to be taken into consideration. I will present these at the hearing because I am still awaiting a response from Ecan from several months ago, an enquiry under the Official Information Act, which I require to complete same.
