2. The reasons for making my submissions are:

We have lived in Templeton for the past 29 and 1/2 years. We chose to buy in Templeton because of the rural quiet area, away from the hum drum of the Christchurch City. We loved the Smaller size Primary School and the friendly people and the Community of Templeton. I feel this Quarry will have a huge effect on our quiet environment. The vibration, noise of machinery, the increased dust, the quality of our water and put our aquifers in jeopardy, therefore effect the quality/quantity of the water in our Village. The contamination from the dust and what effects it will have on my health and that of my small dog.

My concerns are:

- <u>Dust and Vibration</u>— I oppose the application on the grounds it will be an <u>Environmental</u> Disaster for our Templeton village if this quarry will go ahead. This quarry will definitely be too close to our village with a huge disruption to our traffic in the area, and on the roads, the level of noise from the increased number of Truck and trailers. The extra noise from the operation and the time this Quarry will be operable. As we will be so close to the quarry, the vibration of the operation plant and what effect or further damage it could have on our houses and land surrounding the Quarry Site. The dust from the Quarry will propose a health hazard, our well-being and affect our windows let alone our clean washing I put on the line. We grow an organic vegetable garden during the winter and summer and distribute the vegies to our extended family. What impact would this quarry have on our properties, and the people who live here?
- <u>Noise-</u> Machinery possibly operating 24/7 and the noise and vibration, increased truck movement. The impact that this will have on everyone's sleep patterns could lead to a Mental Health situation. Already the Government spends Millions of dollars on this issue.
- <u>Health-</u> I'm near retirement age and the effects it will have on my health is a great worry to me, I walk 6 kilometres every day with my small dog, I don't want to have to wear a mask or I'm sure my little dog won't wear one. I do not want the clean air to be effected in any way. I'm also deeply concerned about the effects this quarry will have on my two grandbabies that live in the Village.

- Roading/Transport Huge increase in the volume of traffic in particular truck and trailer units using our village roads. We have been told as many as 1500 truck and trailer units will pass through our village every day. This will put our current roading under pressure and increase the noise and rumbling on our streets. This increase in traffic will have a huge impact on our Primary School, Kindergarten, Preschool, Before and After School care, Brackenridge Community, Medical Centre, High School Students catching the bus to various Schools in the district. And the elderly that live in our Village. Any given day you will see a large volume of people walking to and from these services. My concern is, we have one pedestrian crossing on Kirk road and the increase in traffic practically the trucks and trailers will be a major safety risk.
- <u>Water-</u> What affect the proposed Quarry will have on our water table? What volume of water will be used on a daily basis and the possible water ponds that I understand are going to be near the boundary and any Mosquito problems in the summer months. Is our water quality going to be compromised??

3. I wish the consent authority to make the following decision:

I strongly oppose this Resource Consent for Fulton Hogan to have a Quarry on Jones road and so close to our Templeton Village. My preference is to have this application Declined however if this Quarry does go ahead I would like the following conditions considered.

- A setback to be imposed of 500 metres from the boundary of the proposed Quarry to the nearest Neighbour.
- I do not want Historical information/statistics to be given to us. I want an up to date accurate information statistics regarding the environmental impact on our Community.
- The planting of Native trees around the Quarry.
- If our health and well-being is affected what compensation will Fulton Hogan offer us?
- A full report on water quality and also the volume of water being used by the Quarry on a 3 monthly basis.
- All truck and trailer units to be covered when full of aggregate!
- No Quarry traffic at all to drive through our village and this to be monitored.
- An audit to be carried out on a regular basis to make sure ALL CONDITIONS to be adhered too!

In conclusion my major concern is the Environment Impact and Spiritual well-being on my family and the beautiful semi-rural area that we chose to live 29 and half years ago. I want to continue enjoying living in what our community in Templeton offers. Going into our retirement years we envisaged a quiet and peaceful life. And in all honesty do we need another Quarry in and around our surrounding area?

I only hope the Commissioners will consider my personal situation and am only one voice and this is my life.
