

### **Reasons comment:**

I am deeply disappointed that the Councils would even consider these applications given the proximity to residential areas. Traffic: The Jones Road / Dawsons Road intersection is already a very dangerous intersection and with increased vehicle traffic it will only get worse. Jones Road is a key connector road to the Selwyn area for the residents of Templeton. It is often impossible to cross State Highway 1 to travel to Rolleston due to traffic volumes. Jones Road should therefore not be congested to further eliminate safe transport options for Templeton and surrounding areas. Large truck movements will damage the road surface and slow traffic down on the very important Jones Road. Jones Road to Kirk Road is not constructed to handle large truck movements. Truck movements will need to be banned on certain areas. Dust and noise may cause issues health. Noise from crushing aggregate on quiet mornings/evenings travel far. The noise may interrupt sleep for many. The area is already surrounded by noise from the airport and Ruapuna raceway and that noise alone is too much to handle. Save our water and keep our water clean. The footpath opposite the quarry site is fabulous for recreational use, however it will be less enjoyable to walk/cycle alongside noisy and dusty quarry operation with large truck movements. Use the land for something that will benefit the community, not a business. Do something decent for the people living on the edge of the Selwyn border. House prices will plummet if a quarry proceeds.
