Map B-C05	Salmon Spawning Sites	Oppose	Large sections of the Salmon Spawning Sites identified within the Isaac Trust landholdings (Lot 2 DP 318667 & Lot 1 DP 83039) are ephemeral, dry for the majority of the year and with permanently grassed beds, which are understood to not be conducive to salmon spawning.	Delete the Salmon Spawning Sites identified within the north and eastern parts of Isaac Trust landholdings.
Map B-C05	Indigenous Freshwater Species Habitat	Oppose	The Indigenous Freshwater Species Habitat identified within the Peacock Springs area of the Isaac Trust landholdings correctly notate the current location of Canterbury Mudfish colonies within the site. The Trust has worked for many years, and continues to work, with the Department of Conservation, to establish and manage colonies of Canterbury Mudfish within Peacock Springs, where suitable areas to locate the Mudfish are found. The colonies are not naturally occurring in this location. The Mudfish colonies are a valued part of the Trust's conservation work. However, the location and survival of the colonies is dependent on the availability and quality of groundwater. The level of the groundwater table within the site is highly variable. For example in 2018 parts of the upper reaches of the Otukaikino Stream, within the site, dried up entirely and went underground. The water table is influenced by the Waimakariri River, farming practice and water takes, other nearby activities, and climate change generally. If the water table drops significantly or water quality becomes an issue, the Mudfish colonies may no longer be tenable in their current location(s). In which case they would need to be relocated. The identification of the Mudfish colonies as Indigenous Freshwater Species Habitat in the LWRP introduces a potential additional cost and constraint to the active management of the Mudfish colonies, by requiring resource consent for works within the habitat of the colonies. The identification is therefore opposed.	Delete the Indigenous Freshwater Species Habitats identified within Lot 1 DP 36807, Lot 1 DP 34362 and Lot 1 DP 21725. Such further or other consequential relief, to the identified provisions or to other provisions under the Proposal as may be necessary to give full effect to the relief sought in this submission.
