The land immediately adjacent to Kellands Ponds is owned by Meridian Energy Limited and stock exclusion is maintained by permanent fencing between MWP and Meridian Energy Land. Other property owners surround Wairepo Arm and maintain permanent fencing between their properties and Wairepo Arm.</p> <p>MWP is of the opinion that the Wairepo Arm and Kellands Ponds are not commonly used for freshwater bathing. An internet search finds no reference, in text or images, to either site as being used for bathing. As they are not commonly used for bathing, McIntyre Williamson Partnership sees no reason to include these sites in Schedule 6, as this establishes false expectations and does not reflect the actual use of the sites.</p>	Amend Schedule 6 to delete the Wairepo Arm and Kellands Pond sites from the schedule.
