This is a submission in support or opposition to Plan Change 7 to the Canterbury Land and Water Regional Plan – Part B OTOP Plan Change

Introduction

- 1. Te Rūnanga o Ngāi Tahu is statutorily recognised as the representative tribal body of Ngāi Tahu whānui and was established as a body corporate on 24 April 1996 under Section 6 of Te Rūnanga o Ngāi Tahu Act 1996 (the Act).
- 2. Te Rūnanga consists of eighteen Papatipu Rūnanga who uphold the mana whenua and mana moana of their rohe. Ngāi Tahu whānui comprises over 64,000 registered iwi members. The takiwā (region) of Ngāi Tahu in Te Waipounamu covers the largest geographical area of any tribal authority. Te Rūnanga respectfully requests that Canterbury Regional Council accord this response the status and weight due to the tribal collective, Ngāi Tahu whānui, registered in accordance with Section 8 of the Act.
- 3. Notwithstanding its statutory status as the representative voice of Ngāi Tahu whānui "for all purposes", Te Rūnanga accepts and respects the right of individuals and Papatipu Rūnanga to make their own responses in relation to this matter.
- 4. Papatipu Rūnanga are defined in Section 9 of the Act. This includes Te Rūnanga o Arowhenua (hereafter referred to as Arowhenua).
- 5. The recommendations within this response re-iterate the desire of Arowhenua to see all freshwater as being drinking water quality. Arowhenua therefore seek recommendations and actions that improve water quality and quantity rather than providing for, and maintaining, the status quo. For this reason, Arowhenua consider the proposed plan change provisions could go further and set a clearer direction so all freshwater bodies achieve higher quality beyond, in some

instances, just achieving the national bottom lines of the National Policy Statement for Freshwater Management 2017 (NPSFW 2017).

Structure of this Response

- 6. Overarching comments are provided within this submission including detailed changes to provisions within Appendix A, B and C.
- 7. Where a matter is not specifically addressed in this submission the direction is broadly supported by Arowhenua. However, Arowhenua seeks that there are no changes made that weaken the effectiveness of the provisions proposed in Plan Change 7, bearing in mind the matters identified in paragraph 5 above.

Setting of Allocation Limits

- 8. Arowhenua oppose the environmental flow and allocation limits, and the timeframe within which reductions will take place for the Te Umu Kaha / Temuka River, Öpūaha / Opuha River and Te Ana-a-Wai / Te Ana Wai River. The Plan change means that these water bodies of significance to Arowhenua will remain in a poor state for future generations. Arowhenua do not consider the flows proposed are sufficient to maintain natural processes; water levels; prevent nutrient enrichment at the hāpua; or protect indigenous biodiversity at key life stages e.g. the migration of large tuna (eels).
- 9. Arowhenua consider that any phasing out of over-allocation should commence from the date that the plan change is made operative with a view to reductions being achieved by 2025. Such an approach would better give effect to the requirements of the NPSFW 2017.
- 10. The proposed allocation of water for mahinga kai in the Te Umu Kaha / Temuka River will achieve very little environmental benefit, nor meet the values of Arowhenua, nor protect the river which is already stressed. The matter of national significance in the NPSFW 2017 is Te Mana o te Wai, which requires putting the needs of the waterbody first and prioritizing the three hauora values (water, the environment and people) above uses of water. The proposed mahinga kai allocation does not achieve this. The Cultural allocation of 100 L/s is not sufficient for Arowhenua to use, as well as protecting mahinga kai values. Arowhenua will opt not to use the water take as they prefer to keep that water in the river systems in order to protect mahinga kai species and their habitats. By not using their allocation (in terms of abstractions or diversions), Arowhenua understands that is at risk of having the water take taken off them in the future when the Canterbury Land and Water Regional Plan document is reviewed, which would reflect the incorrect prioritisation of values in terms of the NPSFW 2017 and the Canterbury Water Management Strategy and a presumption in favour of "use". Retention of water in stream is a valid use and is entirely consistent with the national significance of Te Mana o te Wai. Arowhenua seek means by which this water is protected from being taken or used in a means that is not for the direct benefit of the Te Umu Kaha / Temuka River.
- 11. While the addition of provisions that provide for mahinga kai enhancement is acknowledged, there is a general concern that it is more difficult to undertake mahinga kai enhancement than it is to undertake activities which have an adverse effect on the environment. Arowhenua request the restricted discretionary activity status of the relevant rule is reviewed and instead made a controlled activity, subject to appropriate conditions.
- 12. Arowhenua also request the requirement to prepare a Cultural Impact Assessment is removed when undertaking mahinga kai enhancement. While the intent of requiring a Cultural Impact Assessment is understood, it is the wrong mechanism. It is suggested that the matters of control should have regard to the effects on mahinga kai enhancement and engagement with Arowhenua.

- 13. Arowhenua do not support bringing new water into the OTOP zone or mixing water between catchments within the OTOP zone. It does recognise there is need for a provision which addresses this issue, in as far as it provides clear direction as to the regulatory requirements of undertaking this activity. Having said that, Arowhenua do not consider the activity is appropriate and seek that this be discouraged by the relevant provisions. Bringing in out of catchment water should be discouraged particularly where it becomes a mechanism to offset the effects of land use on water quality, where a change in land use practice would also achieve the same outcome. Arowhenua seek that the Mauri of the water bodies is appropriately strongly weighted against the matters such as any benefit land users may gain from mixing water. It is requested that the activity should be at least a non-complying status.
- 14. The specific changes are found in Appendix A.

High Nitrate Concentration Areas

- 15. Arowhenua broadly supports the inclusion of provisions to reduce nitrogen limits within areas identified as having high nitrogen concentrations. They do however consider it necessary for reductions to go further and faster across the region, particularly where significant nitrate reductions in some areas are generations away.
- 16. The decision on limits has focused on the continuation of existing uses rather than actively exploring whether or not continuing farming practices that have high nitrate loss in these areas is appropriate. The approach is further diminished because the timeframes for achieving Good Management Practice (GMP) baseline, as anticipated by Plan Change 5, will not be achieved until 2025. This delay in achieving GMP baselines then pushes out further the timeframe for reductions. Again, it is considered that this approach is inconsistent with the NPSFW 2017 and inappropriately prioritises land and water use for agriculture and industry above Te Mana o te Wai.
- 17. Arowhenua is also concerned that advice from the GMP Technical Working Group with regard to the reliability of the fertiliser and irrigation proxies of the Farm Portal may impede or diminish the outcomes intended by this amendment, should this part of Plan Change 7 proceed. The fertiliser and irrigation proxy are central to those components of Plan Change 7 that are seeking to manage to freshwater limits. Assurance is sought that this will not be the case.
- 18. Arowhenua seek that consideration is to be given to the effects of the amendments proposed to the National Policy Statement for Freshwater Management and the proposed National Environmental Standards. Where the proposed NES will achieve limits and achieve outcomes that exceed those sought by the OTOP Zone Committee, Arowhenua seek that amendments are made to the provisions to adopt more stringent controls.
- 19. The specific changes are found in Appendix A.

Protection of Rock Art Sites

- 20. Arowhenua are supportive of provisions that being included in Section 14 to protect rock art sites located within the OTOP zone. Additional amendments are however sought.
- 21. Arowhenua support the inclusion of 'Rock Art Management Area' maps that provide a buffer area around each recorded rock art site.
- 22. Given the importance of rock art and these taonga being contained within a prescribed area Arowhenua seek that provisions that avoid or consider the effects on the mapped 'Rock Art Management Areas' are included as triggers in rules (including permitted activities) related to land use, to the take and use of water, and to the discharge of water or contaminants. This will ensure that the adverse effects of these activities are managed to ensure that these nationally and culturally important rock art sites are protected.

- 23. Minor amendments are also suggested to remove reference to tuhituhi neherā and consistent reference to the mapped areas.
- 24. The specific changes to the relevant rules and policies in the OTOP Chapter are in Appendix B.

Protection of Waipuna and Mātaitai

- 25. Arowhenua are supportive of provisions being included in Section 14 of the Plan to protect waipuna (springs) and mātaitai located within the OTOP zone, however amendments to the provisions are required. These changes to the OTOP Chapter are outlined in Appendix C.
- 26. Environment Canterbury has proposed a Mātaitai Protection Zone which provides a zone around the existing mātaitai reserves in OTOP. This approach recognises the importance of protecting mātaitai reserve areas from land and water use activities. Arowhenua seek that this is expanded to afford protection to the waipuna in the Ōrāri/Orari and Pureora/Pareora catchments.




Figure 1: Extension of Protection Zone to include springs within the proposed blue line.




Figure 2: Extension of Protection Zone to include springs within the proposed blue line.

- 27. Waipuna/spring water is regarded as one of the purest forms of water and all waipuna are taonga to Ngāi Tahu. Given the cultural significance of springs to Ngāi Tahu, Arowhenua seek that the 'Mātaitai Protection Zone' be extended to encompass a large cluster of springs located between Timaru and the Ōrāri/Orari River and a large cluster of springs south of Timaru. These extended zones are identified by blue lines on Figures 1 and 2 in Appendix C of this submission. This does not cover the full extent of waipuna within OTOP and Arowhenua supports the changes to protect waipuna across the region.
- 28. Arowhenua also seek that the Mātaitai Reserve areas are given greater protection from a wide range of activities including stock exclusion via specific separation distance provisions within the regional rules. Arowhenua propose the inclusion of separation distance requirements to the Mātaitai Reserves in multiple rules related to the discharging of contaminants, various land use activities and to the taking and using of water.

Conclusion

- 29. The amendments and additions Arowhenua seek to this plan are to better incorporate the broader interests and aspirations of Ngāi Tahu and Arowhenua in managing the impacts of activities across the OTOP area and addressing rights and interests. Arowhenua consider these changes are necessary to:
 - achieve the purpose of the Resource Management Act 1991;
 - give effect to the National Policy Statement for Freshwater 2017;
 - give effect to the operative Canterbury Regional Policy Statement;
 - take into account relevant iwi management plans; and
 - recognise protected customary rights.
- 30. These reasons apply to every decision requested in this submission, along with any additional specific reasons listed under each submission point.

Decisions Sought

- 31. The specific decisions sought are listed in Appendix A, B and C. Text to be deleted is either described narratively or shown as strikethrough (except where whole sections are to be replaced). Replacement text is either described narratively or shown as bold underlined.
- 32. Where a specific provision is not addressed Arowhenua seeks that this not amended in a way that diminishes its intent where the amendment would diminish Te Mana o te Wai and Te Mana o te Whenua (the mana of the land).

- 33. Arowhenua also seek any consequential amendments necessary to give effect to the decisions sought.
- 34. The reasons for our support or opposition are also set out in Appendix A, B and C.

Te Rūnanga o Arowhenua and Te Rūnanga o Ngāi Tahu <u>wish to be heard</u> in support of my submission. If others make a similar submission, Te Rūnanga o Arowhenua and Te Rūnanga o Ngāi Tahu will consider presenting a joint case with them at a hearing.

Rename as "Mātaitai and Waipuna (springs) protection zone"

Arowhenua seek to extend the Waipuna (Springs) Protection Zone to include the springs within the area outlined in blue on Figures 1 and 2 below. A large number of springs are located on the south and north side of the $\bar{O}r\bar{a}ri/Orari$ River and south of the Pureora/Pareora River, which require protection.
